REQUIREMENT FOR CREW VISA

1. Original Passport with at least six months validity and available visa pages. (Non-American passport need to provide Green Card Copy or Documents showing legal status in U.S.)
2. Duly filled one Crew Visa application form with two photos taken within the past six months. The form must be filled completely.
3. An invitation from a local air line and/or a recommendation letter for the employment from where the applicant belongs to.
4. A copy of Crew License.
5. For the crew on board a special flight:
 - a. The Recommendation by the country concerned to certify that the special aircraft is used for the official visit by the head of state or government.
 - b. The Landing Permission by the Ministry concerned and application by sponsored company for the crew and personal undertaking in the event a special aircrafts owned by private individuals.
6. Letter Addressed to Consulate General.
7. Prepaid Self-Addressed Return Envelope or Airway bill
(For those who apply through courier services can use FedEx, UPS or USPS with Tracking Numbers. **Myanmar Mission assumes no responsibility for any delay or loss of mail or documents while under the custody of courier services. The applicants shall note the tracking numbers of all used and submitted envelopes.**)
8. Payment can be made by Cashier's check or Money Order. Payment arranged through Credit Card/Personal Check is not accepted.
9. **Incomplete application will rejected at the counter. Incomplete application through courier service shall be sent back to its original destination.**

Visa Information

- The stay for Crew Visa is **90 days**, which is extendable by submitting concrete evidence.
- The validity of the Tourist Vis Crew Visa is 3 months from the date of issue, which cannot be renewed or refunded. Myanmar Mission will issue visa for completed application as soon as receive it.

Visa Processing Time

- Minimum 3 working days for complete applications.

Photography Guide (2 Photos for Crew Visa)

- a. The photograph must have been taken within the last six months.
- b. The photograph should be in color with the white background.
- c. Photo Size: 35 mm X 45 mm or standard photo size of 2 in X 2 in
- d. Photo Appearance: The photograph must be a full-face view in which the visa applicant is facing the camera directly. Side or angled views are NOT accepted.
- e. Digital Photos: Digitally reproduced photographs must be reproduced without discernible pixels or dot patterns.
- f. Photocopied photographs are NOT accepted.
