REQUIREMENT FOR OFFICIAL VISA

1. Passport holder who work in International Organization, INGOs and NGOs and whose purpose of the visit is either under consultant contract with Myanmar Government or registered UNOs or INGOs or NGOs in Myanmar can apply Official Visa.
2. Original Passport with at least six months validity and available visa pages.
(Non-American passport need to provide Green Card copy of Document showing legal Status in the U.S.)
3. Duly filled one Official Visa application form with two photos taken within the past six months. The form must be filled completely.
4. The request letter from the Organization in U.S. and the invitation letter the Organization in Myanmar with a copy of its valid registration certificate according to Myanmar Association Registration Law.
5. Prepaid Self-Addressed Return Envelope or Airway bill
(For those who apply through courier services can use FedEx, UPS or USPS with Tracking Numbers. **Myanmar Mission assumes no responsibility for any delay or loss of mail or documents while under the custody of courier services.** Incomplete application is not accepted and shall be sent back to its original destination.
6. Copy of Flight Schedule/Itinerary
7. Payment can be made by Cashier's check or Money Order. Payment arranged through Credit Card/Personal Check is not accepted.
8. **Incomplete application will be rejected the counter. Incomplete application through courier service shall be sent back to its original destination.**

Visa Fees

Single Official Visa	-	50 USD
Multiple Official Visa with 3 months validity	-	200 USD
Multiple Official Visa with 6 months validity	-	400 USD
Multiple Official Visa with 1 year validity	-	600 USD

VISA Information

- The validity of Official (Single Entry) is three months from the date of issue, which cannot be renewed or refunded.
- The stay for the Official visa is 70 days, which is extendable.
- Multiple Journey Entry Official visa (MJEV) validity is varies from minimum 3 months to maximum 1 year from the date of issue. Duration/Period of stay in Myanmar restricted to ten weeks from the date of arrival.
- Application of Multiple Journey Entry Official visa (MJEV) is consider and issue on case by case basis at the discretion of the Visa Officer. However, First time visitors for business purpose are not eligible to apply MJEV). Those who want to apply MJEV need to submit the personal letter and detail program.

Visa Processing Time

- Minimum 3 working days for complete application.

Photography Guide (2 Photos for Official Visa)

- a. The photograph must have been taken within the last six months.
- b. The photograph should be in color with the white background.
- c. Photo Size: 35 mm X 45 mm or standard photo size of 2 in X 2 in
- d. Photo Appearance: The photograph must be a full-face view in which the visa applicant is facing the camera directly. Side or angled views are NOT accepted.
- e. Digital Photos: Digitally reproduced photographs must be reproduced without discernible pixels or dot patterns.
- f. Photocopied photographs are NOT accepted.
