Chairman of State Administration Council Prime Minister Senior General Min Aung Hlaing attended the opening ceremony of the upgrading of Pwe Kauk Waterfalls (B.E Falls) in Pyin Oo Lwin on 9 December. Then, the officials opened the ceremony by cutting ribbons and the Prime Minister pressed the button to open the Signboard of the Arch of the Pwe kauk Waterfall Resort (BE Fall).

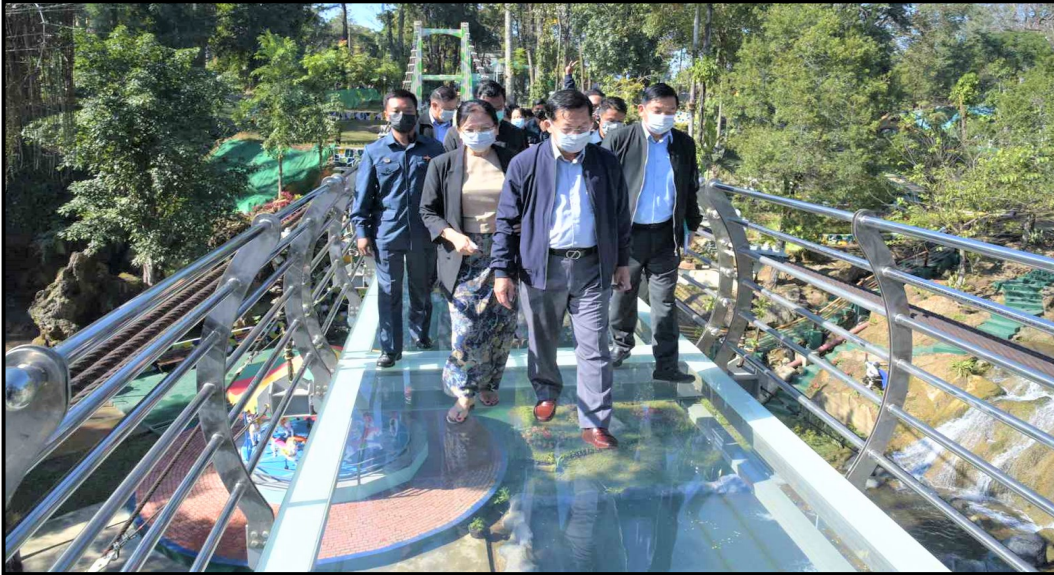
The Prime Minister and party posed for documentary photographs and viewed the surroundings of the waterfalls over the LED glass bridge that meets international standards, studied the vehicles used in Pyin Oo Lwin in ancient times, a suspension bridge and log houses, and then fed baby elephants.

Afterwards, the Prime Minister and party enjoyed the tricks performed by the mobile public relations corps at the roofed stadium playground inside the Pwe kauk Waterfall Resort (BE Fall) and provided cash rewards for the performers of the corps. They also observed and encouraged the shops selling local products and Smart P

shirts, spraying water with solar agricultural irrigation system and the plantations where water is supplied by using solar energy.

The Pwe kauk Waterfall Resort (BE Fall) is-

- Located near Pwe Kauk Village between Mandalay-Lashio railway and the motor road. It was established as a resort for posterity to commemorate the engineering training battalion which had based there and defeated insurgencies in 1949, when Pyin Oo Lwin was occupied by insurgents.
- The Pwe kauk Waterfall used to have no systematic layout, increasing number of shops, unregulated dumping and deforestation which all caused environmental and ecological damage. Therefore, the upgrade was carried out under the guidelines of the Prime Minister during his previous visit.
- As the natural water purification system is used in the waterfalls for purifying water, those who want to play in the clean and healthily water can play in it.

## Chairman of State Administration Council Prime Minister Senior General Min Aung Hlaing Met with Departmental Personnel of Pyin Oo Lwin District in Mandalay Region to Discuss the Development Tasks of Pyin Oo Lwin



Chairman of the State Administration Council (SAC) Prime Minister Senior General Min Aung Hlaing met with Mandalay region cabinet members and departmental officials from Pyin Oo Lwin district and township at the meeting hall of the Tatmadaw guesthouse in Pyin Oo Lwin on 9 December, and gave instructions on matters relating to the development tasks of Pyin Oo Lwin.

After the Prime Minister of the State heard the reports on the use of modern techniques in growing coffee plans for the development of rural people in the Pyin Oo Lwin area, the facts about Pyin Oo Lwin district, the agriculture and livestock sectors, reopening of schools and preventive measures against COVID-19, and the sanitation and beautifying of Pyin Oo Lwin by respective officials, the Chairman of the SAC Prime Minister stressed the following points:

- Pyin Oo Lwin is an attractive city to local and foreign travellers. Efforts are being made to shape Pyin Oo Lwin as a hill station in its original style during the

period of our government.

- The international community shows interest in measures of the town. Taking such an advantage can bring benefits to the tourism sector. As such, Pyin Oo Lwin is being shaped to have beautifying measures meeting the international standard.
- Regarding to the cultivation of coffee, local farmers need to abide by the disciplines for cultivable lands and try hard to complete the cultivation of the plants in the designated years. The government set a coffee zone with the allotment of farmlands for the cultivation of coffee plants in Pyin Oo Lwin.
- Flowery plants were grown in the past but cultivable lands are used in other measures, leaving the lesser sown acreage of agricultural tasks. Relevant departments need to conduct research on agricultural tasks and create a market for agricultural products.
- Pyin Oo Lwin has cream production businesses that can produce quality prod-



ucts. Therefore, the local people need to strive not only for the domestic market but for the export of cream from Pyin Oo Lwin to the international market.

- With few job opportunities inside the country, many workers have to go abroad. The State and the Tatmadaw are taking measures to take back those working abroad. Respective regions are urged to improve their economy to create job opportunities for the people. Already-existing favourable geographical conditions should be effectively used.
- Forests need to be maintained to prevent deforestation.
- In agricultural undertakings, strains, land, water and techniques must be used in systematically combination to increase per acre yield. Systematic livestock breeding is required to get natural fertilizers for agriculture.
- Efforts must be expedited for boosting the per-acre yield of the crops grown in the cultivable lands to be able to minimize deforestation.
- Prevention of deforestation is a must for Pyin Oo Lwin and its environs. Then,

there will be more trees and forests in the watershed areas contributing to climate.

- Due to low water flow into the Kandawgyi Lake, I sought coordinated efforts to increase water levels in the lake during my September tour. Now, water has flowed to the lake to a certain degree.
- Environmental degradation has caused climate change. With little rainfall, water levels in dams and lakes have decreased. Therefore, we need to conserve the trees and forests.
- Regarding the expansion of urban area, I am giving advice on efforts to increase urbanization. It is necessary to consider for the future project in road building and urbanization. All necessary things must be considered in the urbanization process. In constructing buildings, supervisory measures are necessary in accord with the relevant laws and rules.
- Pyin Oo Lwin railway station and Gokteik viaduct are historical ones. Plans are underway to run trains with locomotives run by coal firing from Pyin Oo Lwin to

other places.

- Pyin Oo Lwin must be shaped as an education city while the health standard must be promoted centring in Pyin Oo Lwin.
- Pyin Oo Lwin must be shaped as a clean city and green city as well as a smart city based on Yadanabon Cyber City and Anisakhan Airport.
- Manufacturing tasks must be done through the collaborative efforts of the people. The government has the responsibility to serve the interests of the people. As our task is tremendous and wide, ministries need to cooperate with each other in facilitating their tasks.
- As regards to the COVID-19 pandemic, our country has seen the outbreak de-

crease to a certain degree. But a new omicron variant is spreading in other countries. Responsible officials need to conduct systematic educative campaigns and take supervisory measures as per the COVID-19 disciplines in order to prevent the spread.

The meeting was attended by the Chairman of the SAC Prime Minister together with members and Joint Secretary of the SAC, Union Ministers, Commander-in-Chief (Navy), senior military officers and departmental officials.

- Myanmar regained the Independence on 4 January 1948 and became a member of the United Nations on 19 April. Myanmar cast the vote for releasing the Universal Declaration of Human Rights through the voting decision among member states at the UN General Assembly on 10 December 1948.
- Although human rights are inborn rights of all humans that cannot be erased, they all need to show regard for the rights of others and not to harm these rights in enjoying their rights in line with the important essence of human rights.
- Myanmar also signed the agreements on international human rights such as the International Covenant on Economic, Social and Cultural Rights (ICESCR), the Convention on the Rights of the Child (CRC), the Convention on the Elimination of All Forms of Discrimination Against Women (CEDAW) and the

Convention on the Rights of Persons with Disabilities (CRPD) in addition to some related protocols.

- In order to prevent the inequality and discrimination in every sector, relevant organization including the Myanmar National Human Rights Commission, contact each other with strenuous efforts for enabling Myanmar people to enjoy human rights in equal terms and minimize the inequality in Myanmar similar to that of global countries.

- The government needs to keenly adopt the policies for anti-corruption so as to solve the problems of corruption whereas the framework of the law is of great importance. So, our government has already enacted the anti-corruption rules and is implementing the national anti-corruption strategies to raise the knowledge awareness of anti-corruption, preventive measures against corruption and taking action against the violators.

- In order to emerge a righteous and honest culture in the society, only when the people in individuals participate in the anti-corruption measures of their workplaces and environs will be shaped as a society with honesty free from corruption.

During the ceremony, Union Chief Justice U Htun Htun Oo delivered the matters relating to the integrity in the judiciary sector through video conferencing, and the chairman of the Anti-Corruption Commission U Tin Oo explained the implementation of anti-corruption measures. The ceremony was concluded after displaying a video clip commemorating the International Anti-Corruption Day 2021.

## **Myanmar Objects to Interferences in Internal Affairs and Statements Based on Fake News**

Concerning the verdicts passed against some individuals by the Special Court of Zabuthiri Township of Nay Pyi Taw Area on 6 December 2021, the United Nations officials' Press Statements constitute interference in the judiciary process and internal affairs of Myanmar. Therefore, the Ministry of Foreign Affairs released a statement of strong objections to such statements relied on distorted news.

### **Press Release**

It is observed that Mr Abdou A Barry, Permanent Representative of Niger and President of the United Nations Security Council issued a Security Council Press Statement on Myanmar and that Ms Michelle Bachelet, UN High Commissioner for Human Rights, Mr Thomas Andrews, UN Special Rapporteur on the Situation of Human Rights in Myanmar and Mr Stephane Dujarric, Spokesperson for the United Nations Secretary-General respectively issued statements on the verdicts passed against some individuals by the Special Court of Zabuthiri Township of Nay Pyi Taw Area on 6 December 2021.

The State-owned newspapers have reported the real account of the matter in a timely manner. Every person is equal before the court and no one is above the law. Likewise, it is not appropriate to make a one-sided judgment against the decision of the court which falls within the domestic jurisdiction of a sovereign country. Such acts constitute interference in the judiciary process and internal affairs of Myanmar. Similarly, the UN High Commissioner for Human Rights, the Spokesperson for the United Nations Secretary-General and Mr Ramanathan Balakrishnan, Acting Resident Coordinator of the United Nations in Yangon respectively issued statements regarding the incident that took place in Kyimyindine Township, Yangon Region on 5 December 2021.

The incident was publicly announced in the 7 December 2021 issue of the Global New Light of Myanmar. It is observed that the statements made by the UN do not reflect reality and are deliberately referred to as allegations and unverified online information. Certain foreign embassies also issued similar one-sided statements.

The Ministry of Foreign Affairs strongly objects to such statements which interfere in domestic jurisdiction and rely on distorted news.

The Ministry urges the UN personnel and responsible officials from foreign embassies to stop making one-sided allegations and to abide by the principles of the United Nations and provisions of the Vienna Convention on Diplomatic Relations.

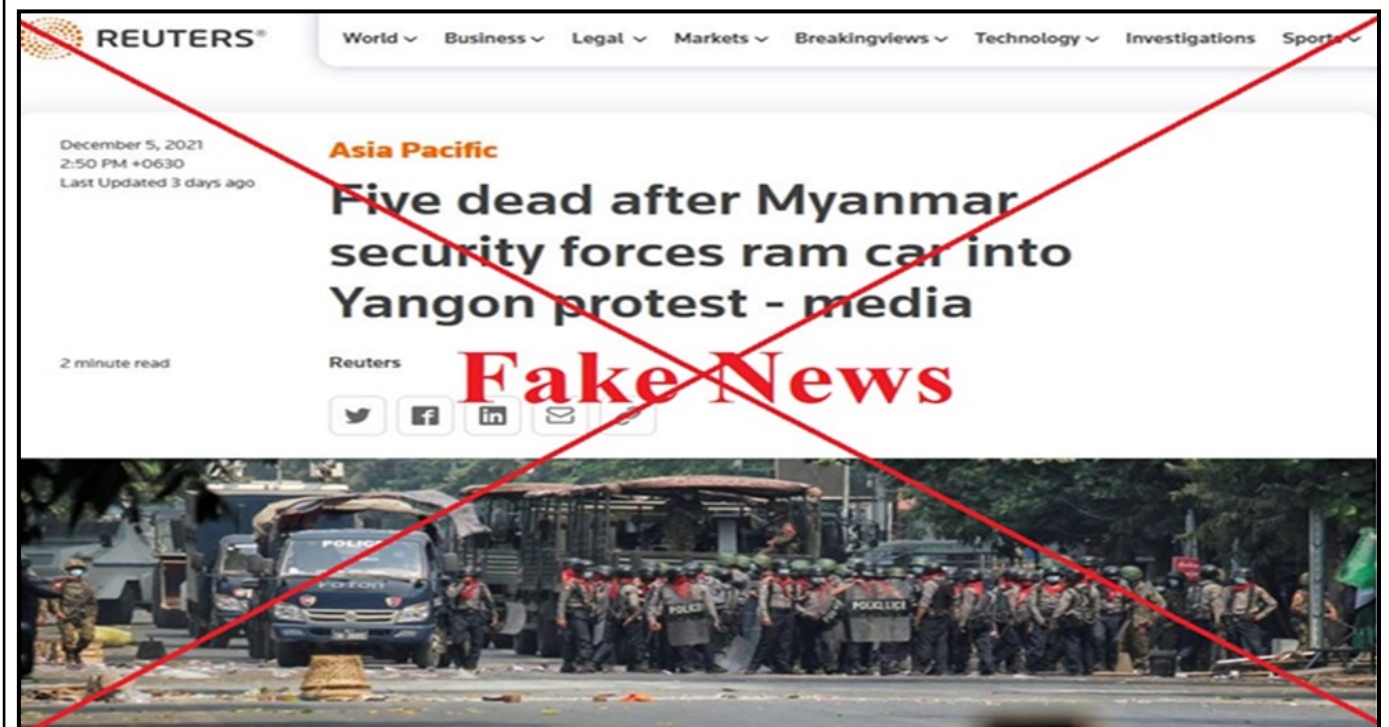
Taking advantage of the current political situation in Myanmar, the local and foreign media that accompany some countries that want to disintegrate Myanmar are inciting bloodshed in various ways to divide the people who want to live in peace and the Tatmadaw, to spread hatred, and to escalate the conflict. In doing so, they provided fake news about the casualties of security forces in order to inspire and motivate terrorists and their supporters. They often broadcast misinformation and fabricate this news on social media in the guise of Tatmadaw torturing and killing innocent people, to tarnish the image of the security forces and mislead the public. This is not just an ordinary act, but a conspiracy of spending a huge amount of money and providing technical support to spread misinformation across social media by synchronizing domestically and internationally.

For example, in the recent incident in Kyimyindine township, Yangon region, an official press release already reported that three rioters were injured in the riots. But notorious exile media, some foreign media, and some international organizations spread false information that, in this protest, has left five people dead and many injured. They are exploiting Myanmar people's kind-hearted minds for their propaganda. It was also found that some foreign embassy issued further press releases on this disinformation without confirmation



to Myanmar officials, to mislead the people and to tarnish the image of security forces.

In reality, according to responsible citizens' information, these protests were not just ordinary protests but were involving terrorists. Therefore, the security forces acted accord-



ing to the Counter-Terrorism Standard Operating Procedures. In such riots, the terrorists targeted and misused some young people as human shields directly or indirectly.

The second misinformation is that the exile media is broadcasting a mispresenting video of the massacre by the Myanmar security forces on social media. The video has been immediately and widely circulated on social media because of a conspiracy by local and international connections. The initial on-ground investigation revealed that the video was not (at all) related to the military and that it was a conspiracy to tarnish the image of the mili-





tary. As a result, security forces are doing necessary investigation to find out the truth.

Therefore, the people who want to live peacefully should be aware of the propaganda



of the expatriate media which are supporting terrorists and terrorism, and not be used as a human shield in terrorist-related riots. We urge the people to continue to work with the security forces to arrest the terrorists as soon as possible.



- The local and foreign media that accompany some countries that want to disintegrate Myanmar are inciting bloodshed in various ways to divide the people who want to live in peace and the Tatmadaw, to spread hatred, and to escalate the conflict.
- They provided fake news about the casualties of security forces in order to inspire and motivate terrorists and their supporters. They often broadcast misinformation and fabricate this news on social media in the guise of Tatmadaw torturing and killing innocent people, to tarnish the image of the security forces and mislead the public.
- In the incident in Kyimyindine township, an official press release already reported that three rioters were injured in the riots. But notorious exile media, some foreign media, and some international organizations spread false information that, in this protest, has left five people dead and many injured. They are exploiting Myanmar people's kind-hearted minds for their propaganda.
- The exile media is broad-casting a mispresenting video of the massacre by the Myanmar security forces on social media. The video has been immediately and widely circulated on social media because of a conspiracy by local and international connections. The initial on-ground

## Armed Terrorists Recklessly Attacked Teachers Using Small Arms

With the certain intention to destroy the rights of children to education, terrorists are committing violent acts such as assassinating the education staff, blowing up and burning down the schools, entering the schools by force and destroying the furniture, and also shooting the security force members who are taking security measures to ensure the safe and peaceful study students at schools.

The terrorists are doing reckless actions of sabotages and assassinations as follows:

- On 9 December in Dagon Myothit (South) of Yangon region, a teacher called Daw Zun Htet Htet Win (29) riding a bicycle on the way to her home from No (2) Basic Education Primary School, two male terrorists riding a motorbike shot her from behind and drove off.
- Due to the shooting, Daw Zun Htet Htet Win got gun-wounds both on her right and left arms, and also on her shoulder. Therefore, she was taken to local military hospital to take necessary treatments.
- On the same day, while U Hla Wai (49) resident of Minpine ward of Twantay township and his wife Daw Su Su Aung, a high school teacher were at a tea shop, armed terrorist called Thein Htike (33) with a motorbike arrived there, shot them with a gun and drove off.
- Due to the attack, U Hla Wai die on the spot with the gun-shot wounds and Daw Su Su Aung also got severe gun-shot injuries.

- Near the scene, the KENBO-125 motorbike used by the culprit Thein Htike, a Sig Sauer P226 pistol, 3 rounds of A USA LUGER 9 mm bullet and five its bullet shells were found and confiscated.

The terrorist group so-called PDF are brutally assassinating the conscientious teachers teaching students without joining CDM. Regardless of the country, religion and faiths, teachers are the ones who are teaching their pupils with benevolences, passions and loves. Reckless assassinations of teachers without any grudge is simply the acts of terrorism which cannot be accepted by any other countries in the world. Therefore, the people are wanting the international communities to prevent and denounce the violent acts of NUG/PDF terrorists.

A group of armed terrorists (being scrutinized) blew the railway line between Thabyaetown and Samone station near the bridge (691) of Yangon-Mandalay railway line near Htanbingone village in Wundwin township of Mandalay region, aiming for cutting off road and communications.

When security forces went and checked to the scene according to received information, two feet of railway line was destroyed due to the mine blast. Running of train was cut off and concerned officials are carrying out the railway line to repair quickly.

NUG/PDF terrorist members and their subordinates of terrorists are committing terrorist acts on public transport vehicles and communications which are crucial for daily people's lives. Socioeconomic of

innocent people was affected by such destructive acts, delaying their activities. ### **So-called PDF Terrorists Again Perpetrated Arson Attacks on Public Houses in No. (2) Ward of Thantlang Town**

On 8 December, around 30 terrorists approached near Myoma police station in Thantlang town of Chin state to perpetrate terrorist activities. Then the terrorists exchanged fire with the police station and they run away to the direction of east. On the way of their retreat, the terrorists carried out arson attacks on the public houses in No. (2) ward causing a fire outbreak.

When security forces arrived there for inspections, it was reported that eight one-storey houses (with plank flooring, zinc-sheet roof and cover), two one-storey houses (with plank flooring, zinc-sheet roof, and wooden wall), and three two-storeys houses (with plank flooring, zinc-sheet roof and cover) (a total of 13 houses with estimated worth around K20 million) were destroyed in fire.

So-called PDF terrorists, by the directives of the NUG terrorist group, carried out the arson attacks on the public houses, shopping facilities, and churches as shown

in the table below by fabricating misinformation portraying as if the administrative mechanism of Thantlang town was in disorder, and armed conflicts prevail everywhere.

PDF terrorists set fire in Thantlang town and run away for nine times. later, they made fake news and fabrications portraying as if the security forces arriving there for extinguishing the fire outbreak were responsible for the burning houses and places by recording the incidents with drones. Then they spread the fake news on social media by contacting foreign media to cause misunderstanding between people and security forces. Therefore, security forces are taking necessary security measures to restore stability and the rule of law in the area.

## Perpetrators who Carried out Acts of Terrorism in Mandalay Region Seized with Arms, Ammunition and Explosives

As terrorists are doing assassination and acts of explosion in order to jeopardize the State's administrative mechanism and to harm the people living in peace and those who do not support terrorists, security forces are carrying out security duties day and night. Meanwhile, due to the report of a conscientious civilian reported on 8 December, security forces seized;

- Khin Maung Htwe, with a 9mm pistol and 14 rounds near "Tone Tone Store" in the eastern part of Thabyu Seinban, 38x90 St.
- Other two perpetrators who were involved with him in acts of terrorism at the East Patta and Nyaunggon ward in Maha Aungmyay township,
- A perpetrator of Aung Myint Myat with a 9mm pistol, 3 magazines and 150 rounds, 3 MG-1 grenades, 3 different mines, 177 homemade mines, 100 feet of detonating cords, 220 detonators, 50 bul-

letproof shields, a cell phone, and other explosives related materials at (Salain-2) ward in Chanmyathazi township.

Five times of assassination and destructive explosion done by those perpetrators according to their confessions are as follows:

- Khin Maung Htwe and Win Aung stabbed an innocent civilian to death, who lives in Taungmyo of Amarapura township on 26 June, and Khin Maung Htwe stabbed an innocent civilian to death, who lives in Tampawady ward of Chanmyathazi township on 31 July.
- Khin Maung Htwe, together with seven members of Ko Thet-led GZP terrorist group, attacked security forces on patrol in Chanmyathazi township with a homemade bomb, riding a light truck.
- Khin Maung Htwe and Ko Phyo blew up with a time bomb the Road Transport Administration Department office in

Mahaaungmyay Township on 27 September.

- Khin Maung Htwe, Aung Myint Myat and Pyae Sone Aung shot an innocent civilian to death, who lives in the My-outdadineshay Village of Patheingyi Township, on 25 October. Khin Maung Htwe shot a civilian to death, who lives in Aungthaya ward of Chanmyathazi Township on 5 November. Khin Maung Htwe, Ko Thet and Ko Phyo shot a civilian to death, who lives in Seinban Ward of Mahaaungmyay Township on 8 November.
- Khin Maung Htwe, Ko Thet and Ko Phyo shot security forces carrying out guard duty at Ward Administration Office in Mahaaungmyay Township on 21 November. They blew up the vehicles carrying security forces on duty with homemade bomb in Thanhletmaw (West) Ward of Mahaaungmyay on 24 November and near the green grocery Market in Mahaaung Myay Township on 27 November, respectively.

According to their confessions:

- The perpetrator ,Aung Myint Myat, sold a pistol and a .380 gun from a perpetrator , Thuta Aung (being remained to arrest) to Thiha with the price of K4.9 million and gave that cash to Saw David, who live in Mindaeing Ward of Aungmyaythazan Township, to keep them.
- He gained 7 homemade time bombs from another perpetrator. He gave 4 bombs to the perpetrator of Aung Myint Myat and other 2 bombs to the perpetrator called Speed to keep them. He tested a time bomb to blow up.
- It was also found out that the BPO terrorist group leader Min Htet Oo mainly arranged and organized the terrorist

bombings and assassinations in Mandalay city, and moreover, in order to materialize his plans, Aung Myint Myat's father and Phyu Pyar Ko living in Aungmyay Thazan township provided him necessary cash and explosives while extremists of NLD supporters and some organizations from abroad provided him necessary fund.

The people who want to live in peace are disgusted with the bombing attacks and the assassinations of extremists of NLD supporters and terrorists, and therefore, people are sending the latter's information to concerned authorities and security forces. Due to the information tips provided by the people, terrorists killing unarmed innocent people have been arrested and moreover, people and security forces are joining hands together for the community peace and stability.

The arrested terrorists and other their accomplices will be reportedly taken punitive action in line with law.

### Weapons, Ammunitions and Related Items Seized in some Monasteries and Nunneries Across the Country Including Manizawtika Monastery in Singu Township of Mandalay Region

Terrorist groups CRPH and NUG are conducting violent attacks and sabotages in order to undermine the State's peace, stability and rule of law. The terrorist groups have attempted to import weapons and ammunitions into the country using various means. In this regard, they used the religion as a stepping stone to hide the arm cache in some monasteries and nunneries where people are going with beliefs.

As the security forces are doing nec-

essary investigations to prevent such terrorist acts, weapons and ammunitions have been confiscated as follows:

- On 8 December, according to the confessions of U Arsarya (4 years of monkhood) (aka) U Nyi Naing, 39 from Kulae village, Manizawtika Monastery in Singu Township of Mandalay Region, 20 KA guns, its 60 magazines, 7,000 rounds of its bullet, 97 grenades, 54 Energa rifle grenades, 300 electric detonators, 15 viss

- of gun powder, a gun sling and 20 sets of army equipment were found buried into the ground behind the dining hall of the monastery and confiscated.
- On 29 July, a terrorist was arrested along with 14 electrically-triggered improvised rockets, 4 large homemade mines, and other items used for violent acts in Myataung monastery located at 35<sup>th</sup> Rd, 85<sup>th</sup> St x 86 St, Mahaang Myay township of Mandalay region.
  - Following further investigations in the U Awbatha monastery, a short air-gun, 14 IEDs and some cash to be supported to terrorists were also found and seized.
  - On 13 September, the cash robbed from No (1) Sub-Ayeyarwady Bank and the weapons/ammunitions used in the robbery were transferred to the Buddhist nuns of Daw Upathamar and Daw Damasaryi from the Dhmmaduta Nunnery to hide the items. Therefore, security forces arrived there and confiscated the items.
  - Moreover, on 5 December, monk U Pyanyar Nanda (aka) Kyi Nyunt, 66 from Chaydawyar monastery located near Lae Lyaung village, Ngapu Taw township of Ayeyarwaddy region was arrested along with one pistol, two magazines, 20 rounds of 9 mm bullet, one -16 rifle, 4 its magazines, 96 rounds of 5.56 mm bullet, 3 claymore mines and other related items.

The terrorist groups based on their self-interests are committing sabotages and violent acts across the country. In this regard, the terrorists are using the Buddhist religion to support the terrorism by disguising as monks, and then storing and hiding the arm cache in the monasteries.

Committing terrorist acts by disguising as monks will damage the Buddha Sasana of the country making the venerable Buddhist monks and Sangas upset moreover, the majority of nationals devoting the Buddhism are also disgusted with such con-

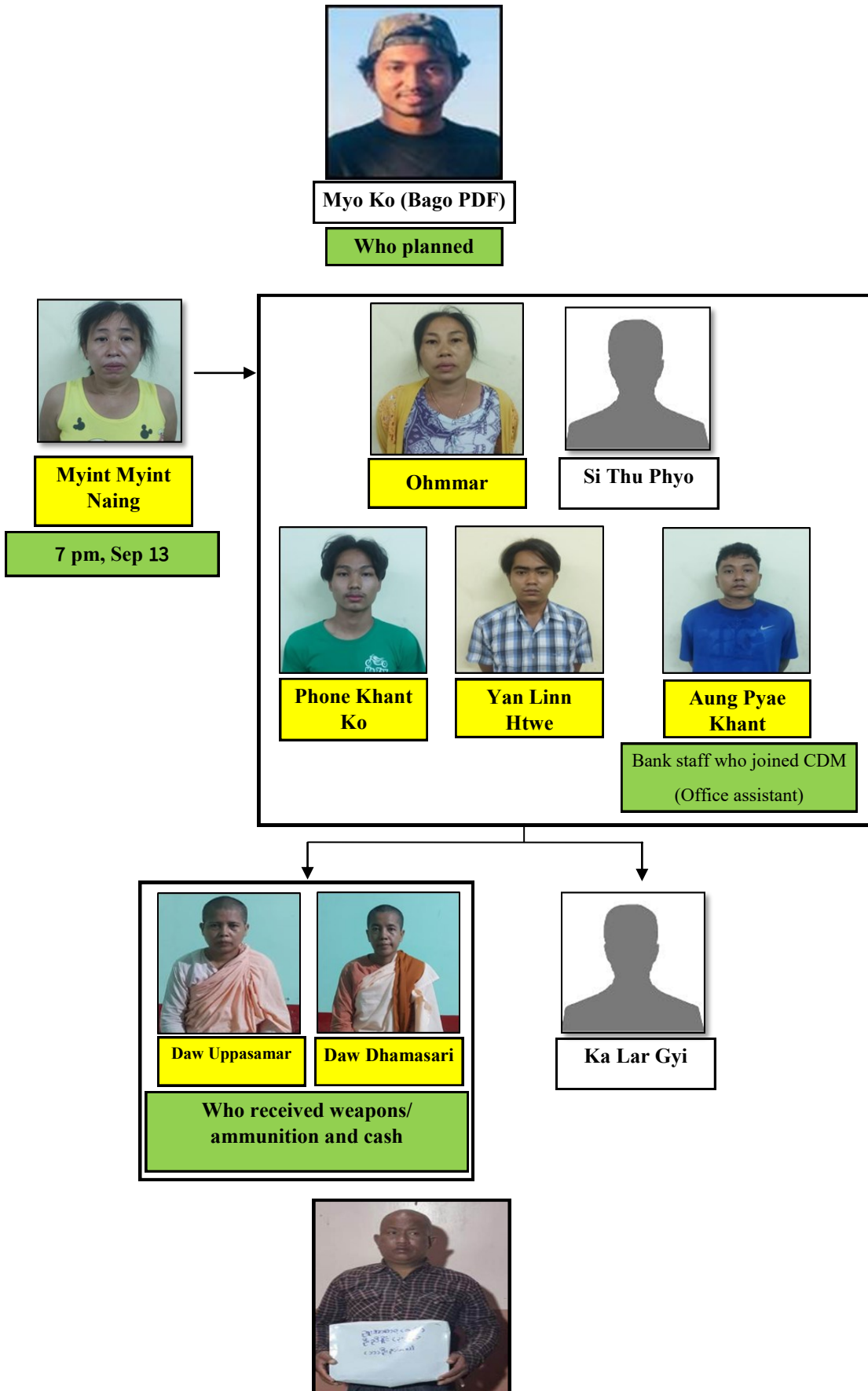

Sone, Hein Min Zaw and Soe Lin Aung lived there and made riots in Mandalay.

- Thura Aung mainly provided required materials, food, cash and accommodation for protestors.
- Moreover, according to the instruction of Thura Aung, they made a plan to organize 'Silent Strike' on 10 December to have fear in the hearts of the people and mislead the international community that the State's administrative machinery is in disorder.
- They were arrested while they were preparing to commit violent attacks against ordinary people going out regularly on that day after regarding them as those who do not cooperate with them.
