## Ancient Temples and Pagodas Thronged with Pilgrims During the Thingyan Holidays



On the occasion of Thingyan festival, famous ancient pagodas and temples across the country are being thronged with pilgrims while beaches are also crowded with people relaxing and playing waters.

During Thingyan holidays, famous historical pagodas, temples and stupas in Rakhine state have been thronged with the local pilgrims from the townships of Min Pyar, Myaypon, Pauktaw, Kyauktaw, Sittwe and Punna Kyun Since 10 April.

It is also reported that over twenty thousand of daily pilgrims reached at the famous pagodas in the Bagan Archaeological Zone. Although the Shwesikhon pagoda is regularly opened from morning 6 am to evening 6 pm, the opening time has been extended to morning 5 am to evening 8 am so that pilgrims peacefully can pay worship to the pagoda. The famous historical pagodas and stupas in Pagan area are also reportedly crowded with pilgrims.

Sat Taw in Minbu (Saku) township of Magway region has been thronged with people of pilgrims overloading the public inns there on the occasion of Thingyan festival.

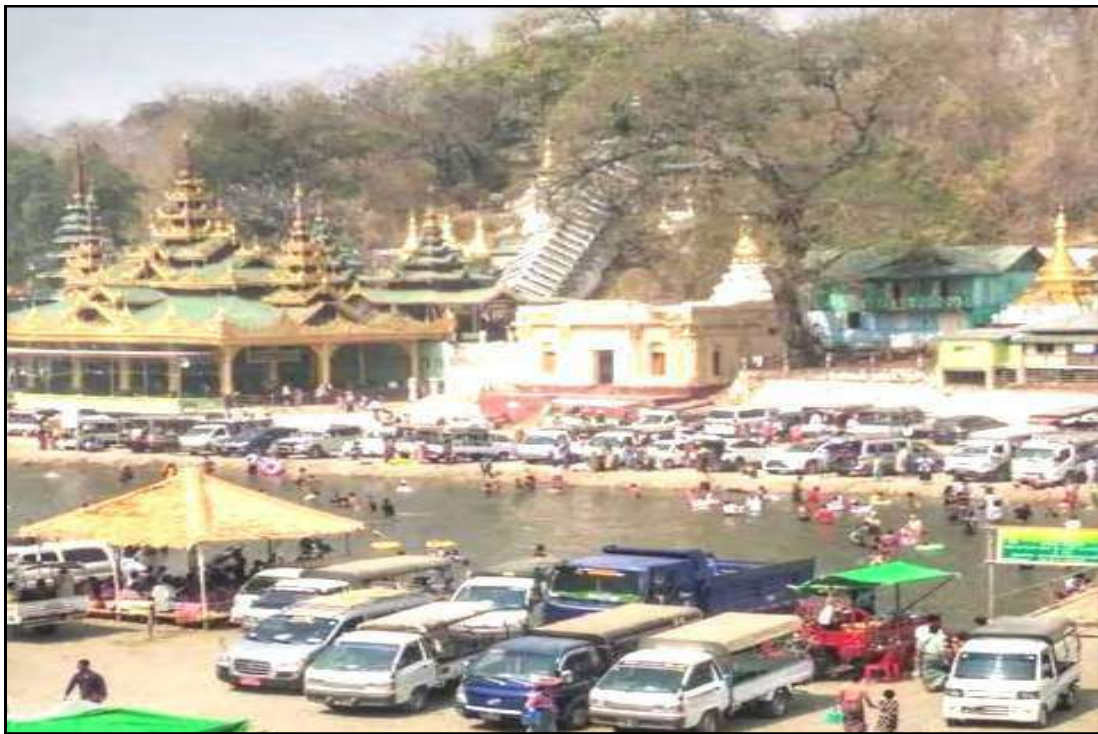

- Water celebration pandals are being constructed in Pabedan, Pazundaung, Botahtaung, and Kyauktada townships and Public Square in Dagon township in Yangon in accord with Myanmar traditions.
- At the Yangon Mayor Maha Thingyan Central Pandal, the celebration will include Yein (group) dance competitions, music concerts by film stars and musicians and performances by theatrical artistes in addition to the Walking Thingyan.

- Myanmar traditional Maha Thingyan Festival of 2022 will be celebrated in full force at seven pandals including central pandal on strand road and six pandals of respective ministries in Magway region.
- From 13 to 16 April in Rakhine state, the water festival will be celebrated in full force at central pandal and another one in Thandwe township and at central pandal and another one in addition to other pandals in Ngapeli township.

## Press Release Regarding the Printing and Publishing Enterprises Supervised in accord with Existing Laws

The Ministry of Information allows the printing and publishing enterprises freely. Meanwhile, some printers and publishers violate the code of conduct by taking a chance on the free press. So, the ministry shuts down such enterprises, revokes the business license certificates and takes signs in a pact under the management system.

In 2021, the following printers and publishers were taken action for failing to follow the regulations under Section 8 of Printing and Publishing Law:

- (a) The business license certificates of one magazine and 11 news agencies were suspended and revoked for expressing subjects that affect State security, the rule of law and community peace.
- (b) One publisher signed a pact under the management system for describing pornography, and the business license certificate of one publisher was revoked for expressing matters

that affect religion.

- (c) Moreover, it also cooperated with ministries concerned to take action against Facebook Page that express things that can affect State security, the rule of law and community peace.

It is here announced for the publishers not to express obscene words and matters that can harm ethnic groups or citizens racially, religiously or culturally. It is required to avoid disrupting national security, the rule of law, community peace and tranquility, equality, freedom, justice and rights of every citizen, encouraging and inciting crimes, brutality, violence, gambling and the offence of narcotic drugs and psychotropic substances. So, Ministry of Information reportedly issued that those who fail to follow will face serious actions under the laws.

## COVID-19 Prevention, Control, and Treatment Activities Continue in Respective Regions and States



**Distribution of COVID-19 vaccines by Cold Chain Delivery Logistics vehicles to respective regions and states as per cold chain standard**

COVID-19 prevention, control and treatment activities such as opening quarantine centres and vaccinating people against COVID-19 continue in respective regions and states.

- Up to 11 April, 28.27 million people in total have been vaccinated against COVID-19. About 22.27 million people have received two-time full doses of the vaccine and 5.99 million people have received the first doses. A total of 51.71 million people have been inoculated against COVID-19 in Myanmar.
- A total of 1,163,932 people have been vaccinated against COVID-19 as booster doses in respective regions and states from 1 January to 11 April 2022.
- Opening ceremony of oxygen plant was held in Bartown Taung of Thandwe township of Rakhine state on 10 April. That plant was constructed with the funds of K10 million of Rakhine regional government and K 150 millions of donation contributed by donors and Sa-

yadaw Bhaddanta Tay Zanda of Parahita Theinkone monastery.

- 4,000 doses of Sinovac vials (each vial can be used for one people) and syringe needles stored at the cold chain centre located on Min Dhamma Road in Mayangon township of Yangon region were transported to Matupi township of Chin state by Cold Chain Delivery Logistics vehicles as per Cold Chain standard on 12 April.

The Ministry of Health is conducting COVID-19 tests regularly, 23 new cases of COVID-19 were detected from testing a total of 7,252 samples and accounting for 0.32 percent on 12 April. Up to 12 April 2022, a total of 612,406 cases were detected from testing a total of 7,798,434 samples and death-toll reached 19,434.

## \$80 Million Generated from Exporting a Variety of Pulses within First Half of 2021-2022 FY



According to the report of the Ministry of Commerce, \$80 million was earned from exporting a variety of pulses within six months of 2021-2022 FY.

From 1 October 2021 to 31 March 2022, US\$780.156 million was generated from exporting 1,028,215.817 metric tons of variety of pulses via sea routes and US\$50.469 million was generated from exporting 61,895.924 metric tons of variety of pulses via border trade route. US\$830.625 million was generated from exporting

1,090,111.741 metric tons of pluses in total.

During the six-month period of 2020-2021 FY, a total of 1,242,775.231 metric tons of variety of pluses were exported generating US\$966.407 million through sea routes and a total of 786,920.651 metric tons pluses were exported generating US\$604.3 million through border trade routes.

## Htann Chaung Bridge in Maungdaw Township Destroyed in the Mine Attack of ARSA Extremist Bengali Terrorist Group Repaired

The ARSA extremist Bengali terrorist group exploded the Htann Chaung bridge located on Kyain Chaung- Taung Pyo road in Maungdaw township using IED in the night of 6 April leaving the bridge damaged. Therefore, the officials from the Department of Road in Maungdaw township repaired the damaged bridge on 7 April.

The Htann Chaung bride is reinforced concrete bridge with 50-feet long and 16-feet width. It is reported that the security force members are now conducting necessary security measures at the incident place.

## PDF Terrorists Carry Out IED Attack to Destroy the Water Pump Plant Owned by Myanmar Oil and Gas Enterprise

On 9 April, PDF terrorists exploded IEDs to destroy the water pump plant supplying water to Latpanto and Thartaung oil fields of Myanmar Oil and Gas Enterprise located to the west of Thamardaw village of Pauk township of Magway region. When security forces arrived there, computer boxes and alternators of two US-made water pump engines were destroyed causing estimate loss of K10 million.

Terrorists of political extremists, with the intents to halt the Government administrative mechanisms and disrupt the State's peace and stability, are killing the non-

combatant targets of innocent civilians, Buddhist monks and civil servants, and destroying and blowing up the public places, facilities and roads and bridges including the State-owned plants and machineries. Therefore, the entire population is disgusted by the inhumane terrorist acts recklessly committed by the terrorists in some townships.

It is reported that security forces continue necessary measures to identify and arrest the terrorists as early as possible.

## KIA Group and PDF Terrorist Groups Fire under Cover of Public Buildings and Residential Houses at Security Forces in Pinlebu Township

KIA and pro-NLD political party extreme PDF terrorist groups has come to launch terrorist acts such as blockades across road, extortions of local residents and travelers, committing motiveless terrorist murders of civil servants and innocent civilians, attacks under the cover of State-owned buildings, public hospitals, schools, residential houses, villages, markets, State-owned banks, departmental offices on security forces members, building military posts around Pinlebu township of Sagaing region. Hence, security forces have to fight back against those terrorist groups unavoidably.

- On 29 March and 1 April, security forces fought with terrorist groups near Kapan-ta village in Pinlebu township of Sagaig region.
- On 3 April, security forces fought against terrorist groups after they spotted a terrorists' hideout around one mile away to the northeast of New Lain village located over eight miles away to the northeast of Pinlebu township.
- In the incidents, security forces captured two dead bodies of terrorists wearing military camouflage uniforms, two M-22 rifle guns, one 40-mm grenade launcher made by KIA, one 79-mm grenade launcher, one homemade shot-gun, 59 bullet rounds of M-22, 15 shells of 40-mm grenade launcher, five magazines of M-22, 131 bullet rounds of 7.62 mm, two homemade grenades, two walkie-talkies, one military camouflage uniform and other belongings from terrorists.
- On 4 April, security forces raided a military post where terrorists are hiding and is located two miles away to the north-east of New Lain village which is located nine miles away to the northeast of Pinlebu township, according to the report of local residents. Then, security forces fought against some 150 terrorists and captured a terrorists' hideout fenced with bamboo, two dead bodies of terrorists wearing military camouflage uniforms, eight shot guns, 18 magazines of



M-22, 135 bullet rounds M-22, two homemade guns and one telescope of sniper rifle and other related items.

- On 9 and 10 April while security forces were raiding the military posts of terrorists, terrorist groups with large-scale force launched an attack on a police station and security forces, taking the cover of the hospital, school, fire-brigade building and Myanma Economic Bank in Pinlebu. Therefore, security forces fought back against terrorists and terrorists got casualties and ran away in disarray to the North of the township.
- In the incidents, some security forces members died in battle and got injured. However, a total of eight dead bodies of terrorists: four dead bodies wearing military camouflage uniforms with KIA/PDF badges and another four dead bodies wearing sports jerseys, five M-22 rifles, two AK-47 rifles, one KIA-made 40mm revolver, one 7.62mm sniper, 22 magazines of M-22, 1345 bullet rounds of M-22, 115 bullet rounds of 7.62 mm sniper, nine shells of 40mm grenade launcher,

19 KIA-made grenades, 17 shells of 60mm mortar and one hand grenade were captured.

- The signs of using narcotic drugs were found in some dead bodies of terrorists and some narcotic drugs and related materials were also found in terrorists' military posts captured.

It is found out that terrorist acts such as firing under the cover of non-military targets of administrative, educational buildings, residential houses in towns/villages at security forces and attacking non-military targets of departmental buildings are breaching against the provisions prescribed in Geneva conventions and International Law.

Legal actions will be pursued to take under the Counter-Terrorism Law, Penal Code and existing laws against terrorists. Further, security forces are continuing necessary security tasks to restore community peace and tranquility.

An incident was occurred that nine males robbed about K217 million from KBZ bank (branch) located on Thanthuma road in South Okkalapa township of Yangon region on 6 April 2022, at gun point. So, the security force members were conducting necessary investigations to identify and arrest the offenders by opening file under criminal code at the Myoma police station of South Okkalapa township. In doing so, as the security force members found out that the offenders committed robbery used the TOYOTA PROBOX vehicle (plate no. YGN 3D/3400) which was used in the incident and they then changed the (plate no. YGN CC/8336) at this vehicle, necessary measures were being taken to seize that vehicle (plate no. YGN 7D/3400). Then, Arkar Kyaw (aka) Arkar, 41, a resident of house no. (147), Homl street no. (4) street, Butar ward of Sanchaung township was arrested

along with this vehicle at Orange store on Homl street in Butar ward on 8 April.

According to the confessions of arrested offenders and their interrogation results:

- An offender was arrested at Hlegu township.
- Three offenders were arrested along with evidence cash K118,000 and a CALD-INA vehicle at Sanchaung township.
- Four offenders were arrested along with robbed cash K10.125 million, five stimulant tablets and one round of 0.380 AUTO bullet at Ahlone township.
- Two offenders were arrested along with K129.94 million, a pistol, a plastic gun and two stun guns at Mingaladon township.
- Five offenders were arrested along with one homemade gun, five rounds of 12

volt bullet, one multi-coloured smoke bombs, two drones, seven kinds of hand-phones and evidence cash K12.5 million at Thongwa township.

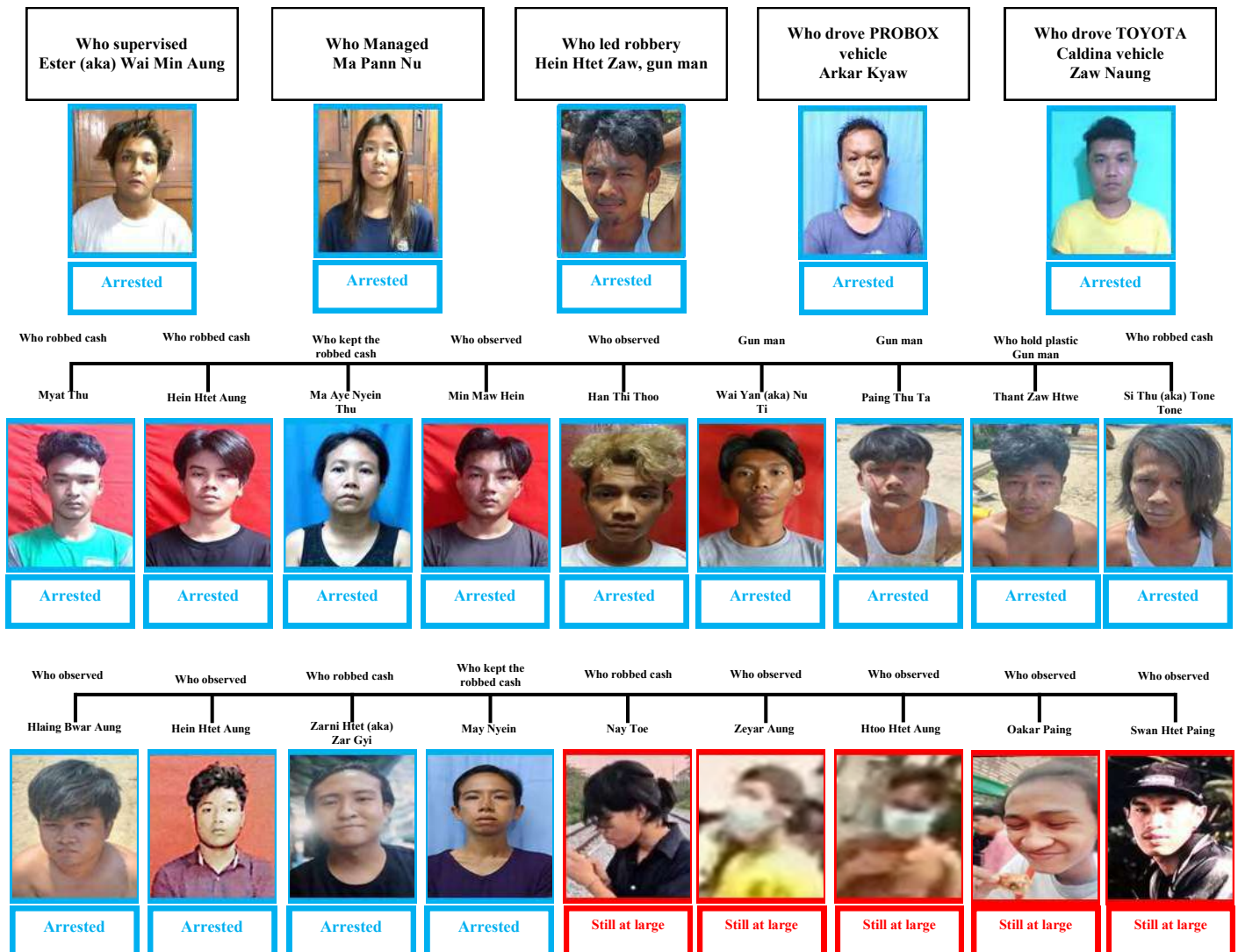
A total of 18 perpetrators (15 males and three females) participated in the robbery were arrested along with evidence cash K115.183 million, four grenades, one smoke bomb, one pistol, two homemade guns, one plastic gun, two stun guns, 49 rounds of .22 bullet, five rounds of 12 volt bullet, two pieces of drone, one round of .380 AUTO bullet, three fuses of grenades, 10 ticals of gundpowder and five stimulant tablets.

Therefore, the security force members are reportedly taking necessary security measures to arrest the offenders who are still at large participated in the incident as soon as possible and take legal action under the law against them.

- ◆ **ARKAR Kyaw** who drove **TOYOTA PROBOX** plate no. **7D/3400** was arrested at **Orange store** at **0900** on **8 April** and other related offenders were arrested according to the confessions of him.
- ◆ **Two MG-1 grenades**, one grenade (under scrutiny for production country and kind), one smoke bomb, one homemade grenade, one pistol, two homemade guns, one plastic gun, two stun guns, 49 rounds of .22 bullet, five rounds of 12 Volt bullet and pieces of two drones were arrested.
- ◆ A total of **23 offenders** (**18 offenders arrested** and **five offenders are still at large**).
- ◆ A total of robbed cash **K217 million**, **K155.183 million** recovered and rest of them are still lost.



## **Actions against Unscrupulous Persons who Follow and Make Incitements and Propaganda of CRPH and NUG Terrorist Groups, their Subordinates and Colluded Groups Continue**

The entire population has already been informed not to follow the incitements and propaganda made by CRPH and NUG, which were declared as terrorist groups, their subordinates and colluded groups. In spite of that, some unscrupulous persons made incitements and propaganda to disrupt the State peace and stability via social media. Therefore, necessary actions have been taken against them in line with law. In this regard:

- On 8 April, each one from Kayin state and Mandalay region, and Nay Pyi Taw Council Territory totaling three were ar-

rested.

- From 27 January to 8 April, legal actions were taken against a total of 263 instigators under the law.

It is reported that necessary actions will be continued against such instigators and unscrupulous persons making propaganda and instigations.
