Chairman of State Administration Council Commander-in-Chief of Defence Services Senior General Min Aung Hlaing Meets Senior Military Officers and Female Officer Trainees in Hmawbi Station

The Chairman of the State Administration Council (SAC) Commander-in-Chief of Defence Services Senior General Min Aung Hlaing delivered an address at the meeting with senior officer instructors and female cadets from the Defence Services (Army) Officer Training School (Hmawbi), trainees from the female platoon commander course and senior military officers from the local airbase at respective halls, on 8 June, separately. During the meeting, the Senior General stressed the following points:

- Female military personnel have been serving duties at the Tatmadaw since 1958. Except for those from medical services, other female military personnel could not be assigned for a period for various reasons.
- When the Senior General serves as the duties of the Commander-in-Chief of Defence Services, he made arrangements to appoint female military officers, and now they are serving duties in Tatmadaw (Army, Navy and Air) and the relevant corps. Tatmadaw is also bringing out female other ranks in its ongoing service-women production program.
- Female military personnel need to take pride in their endeavours serving at the Tatmadaw of their own accord with patriotic spirit because it is difficult for even males to serve at the Tatmadaw.
- Officers, being military leaders, must have brave and sharp. They have to fairly control subordinates under the leadership characteristics. They have to study, practise and comply with the leadership knowledge.
- In serving the Tatmadaw, they must strive for handing over the fine traditions of the Tatmadaw to a new generation of female military personnel in the future.
- As lectures of military science places emphasis on protecting one's own live, it is vital to take the training seriously. During the performance of their duties, it is found that female personnel have

strong morale and it is important to continuously maintain their strong spirit.

Only when the general election can cover the whole nation, the multiparty democracy aspired by the people can be implemented and the Union will be built under democracy and federalism. To do so, Tatmadaw members need to forge the soldier spirit for serving the respective assignments.

Also present at the meetings together with the Chairman of the SAC Commander-in-Chief of Defence Services were Commander-in-Chief (Navy) Admiral Moe Aung, Commander-in-Chief (Air) General Tun Aung, senior military officers of the Office of the Commander-in-Chief, Yangon Command Commander and officials.

The Chairman of the State Administration Council (SAC) Prime Minister Senior General Min Aung Hlaing, accompanied by officials, inspected Pyidaungsu Hall where the National Convention was convened to draw the Constitution (2008) in Hlegu Township of Yangon Region on 8 June. At the Pyidaungsu Hall, the Prime Minister heard the reports on conditions of the damaged parts and preparations for maintenance presented by Union Minister for Construction.

After hearing the reports, the Chairman of the SAC Prime Minister said that these were historic buildings where the Constitution (2008) which is important for the State

was drawn. These historic buildings were maintained as much as possible in successive eras. Due to weakness in maintenance, the damaged parts have come out. Emphasis must be placed on maintenance for the long-term existence of buildings. The Prime Minister and party viewed round the Pyidaungsu Hall and Anawrahta Yeiktha and have instructions to officials.

The National Convention was convened at the Pyidaungsu Hall seven times with the participation of 702 delegates from eight groups from 2004 to 2007 in order to approve the Constitution (2008). The venue where the National Convention was convened is located on 585.81 acres of land,

200 acres of which are designated as the agricultural zone and 100 more acres as the livestock zone. As maintenance is weak, some parts are damaged. Now, the buildings will be placed under maintenance.

Afterwards, the Chairman of the SAC Prime Minister and entourage arrived at Nyaungnapin agriculture and livestock special zone, and the Prime Minister heard reports on undertakings of agriculture and livestock farming works in respective zones presented by the relevant officials. After hearing the reports, the Prime Minister of the State stressed the following points:

- The previous Tatmadaw governments in successive eras have been implementing agriculture and livestock farming works in respective zones for greening the 30th-mile radius area of Yangon City and for local people to have good food supplies.
- Nyaungnapin agriculture and livestock special zone is engaged in cultivation of

crops and perennial crops such as mango, jackfruit, guava and lemon for food supplies and required to grow the vegetables successfully.

- There are daily requirements of meat and fish for the people in Yangon city. Therefore, systematic fish farming is necessary to ensure enough supply to Yangon. Fish is the cheapest of all humans are consuming. Responsible officials are to try to produce fish resources in the long run.

Later, the Chairman of the SAC Prime Minister together with entourage inspected an organic vegetable plantation being operated by the Agriculture Department and Sein Lan Cooperative Society in the zone and the working processes of the poultry farm of CJ Feed Myanmar.

The Chairman of the State Administration Council (SAC) Prime Minister Senior General Min Aung Hlaing delivered speeches at the meeting with ministers of Yangon Region Government and officials at the regional government office on 9 June.

Also present at the meeting together with the Chairman of the SAC Prime Minister were members of the entourage, the Yangon Region C-hief Minister, the Yangon Command Commander, the mayor, Yangon Region ministers, district and township level departmental officials, religious associations, philanthropic organizations, war veterans and officials.

During the meeting, the Chairman of the SAC Prime Minister highlighted the following points:

- All global countries are continuously striving for their development. Hence, Myanmar cannot stay idle. In this regard, the SAC is striving the tasks that should be carried out.
- National development calls for production of a large number of new generation intellectuals and intelligentsia. Enrollment programs for all school age chil-

dren must be carried out as only the educated can acquire technological knowledge.

- COVID-19 has temporarily stopped learning activities in the past. It is regrettable that although the government reopens schools for the learning of students, terrorists pose threats to and kill educational staff and students and destroy teaching aids and educational buildings arranged for the learning of students.
- It can be said that those terrorists destroy the country, leaving many losses to students, parents and the State.
- It is the main driving force Nation-building has three driving forces such as political power, economic power and defence power. As such, political stability and unity will reflect strong politics as well as strong military might and security might will build a powerful defence capability. The two capabilities depend on economic capability. Hence, economic driving force is essential for the country.
- The prosperity of the nation and food sufficiency is a national vision of the

- country. The successive governments have tried to ensure abundant food in Yangon Region, which has favourable water and soil conditions. Yet, it still has weaknesses in agriculture with low yields. So, efforts must be made till success is achieved in agricultural undertakings with better per-acre yield.
- The country has experienced various political systems since its independence. Now, it is on the road to multi-party democracy with two political aims aspired by the people. Multi-party democracy must be practised correctly while a union must be established based on democracy and federalism.
 - It has been noted that federalism is the concept of different regions and states with diverse ethnicities by co-existing together and sharing with each other. Different countries have different federal ways. They are using the system most suitable to them. In Myanmar, internal armed conflicts emerged due to different ideologies.
 - Good results came out of the peace talks with EAOs. Strenuous efforts will be made for the restoration of the nation through proper peace talks.
 - Effective actions and punishments for the rule of law are being used in accord with the law for those committing acts of terrorisms and killings on the pretext of political ideologies. Terrorism is also unacceptable in the international community. In resolving instabilities from the political cause, the government is acting in accord with the democratic ways.
 - Some EAOs cannot participate in the talks for various reasons. In line with the firm implementation of two political visions, the government further invites the remaining groups to hold talks.
 - As the strength of the nation lies within, and only when public -cooperation is better, will the emphasis be placed on the development of the nation. Hence, public service personnel from departmental organizations must conscientiously discharge duties to be able to win the trust of the people.

Afterwards, the Chairman of the SAC Prime Minister and entourage arrived at the Myanmar-Korea Friendship Bridge (Dala) construction project and then inspected the construction of main bridge pylon 2 on Yangon bank of the project site.

During the meeting, Professor Emeritus Cardi Jackson asked about the implementation of the Union Election Commission in accordance with the Five-Point Roadmap of the State Administration Council, its further plans and the conditions for the election. UEC Chairman U Thein Soe said as follows

- The commission and the political parties discussed on the current activities of the UEC and agreed to change the system of

proportional representation suitable for Myanmar.

- Relevant laws rules are being amended and focus is put on the accuracy of voter lists and verifying the census on the ground, screening and preparation of are being carried out.
- Local and foreign observers will be invited in holding elections, and the commission will make free and fair elections acceptable to the political parties, representatives, and voters.
- Although the Tatmadaw assumed State responsibility under the circumstances, it formed the UEC with non-partisans and experienced people to carry to comply with the Five-Point roadmap, focusing on holding elections.



- The country needs stability and peace to hold elections. The commission would work to ensure a free and fair multiparty democratic general election in accordance with the existing laws.

The professor emeritus said he was impressed by the UEC's efforts and prepara-

tions, he would convey a message to the international community and he also remarks that he will provide assistance if necessary.

Union Ministers Receive Cambodian Delegation led by Secretary of State for Foreign Affairs and International Cooperation

U Wunna Maung Lwin, Union Minister of the Ministry of Foreign Affairs, U Ko Ko Hlaing, Union Minister of the Ministry of International Cooperation and U Kyaw Myo Htut, Deputy Minister of the Ministry of Foreign Affairs respectively received Cambodian delegation led by H.E. Dr. Kung Phoak, Secretary of State of the Ministry of Foreign Affairs and International Cooperation and Head of the Office of the Special Envoy of the ASEAN Chair on 9 June 2022.

- During the call with Union Minister of the Ministry of Foreign Affairs, the Minister discussed that Myanmar's Government is holding peace talks with Ethnic Armed Organizations and trying to reinstate democracy in Myanmar. He also reiterated that issues in Myanmar are just the internal affairs of the country and should not be regionalized or internationalized. Moreover, he reaffirmed Myanmar's readiness and willingness to cooperate with each and every ASEAN Member State in the implementation of

the Five-Point Consensus in line with the existing rules and regulations of the Republic of the Union of Myanmar. Next, H.E. Dr. Kung Phoak expressed Cambodia's view to have constructive engagement but not isolation on the issues of Myanmar upholding the principle of non-interference in one country's internal affairs. He then mentioned that Cambodia noted with satisfaction the progress made in the implementation of Point 4 of the Five-Point Consensus including the Joint Needs Assessment. He further exchanged views on the ways and means to implement the other points of the Five-Point Consensus in a mutually agreeable and comfortable manner.

- During the call with the Union Minister of the Ministry of International Cooperation explained that the provision of humanitarian assistance to Myanmar is necessary to be feasible and implementable. He then reaffirmed Myanmar's commitment to realize the outcomes of the

Consultative Meetings in accordance with the rules and regulations of the Republic of the Union of Myanmar as well as to facilitate the distribution of assistance to the people in need without discrimination including Ethnic Armed Organizations. Dr. Kung Phoak expressed Cambodia's appreciation for Myanmar's facilitation throughout the whole process of provision of Humanitarian Assistance to Myanmar including the conduct of the Joint Needs Assessment and explained the ways forward to implement the Point four of the Five-Point Consensus.

- During the call with the Deputy Minister of the Ministry of Foreign Affairs, the Deputy Minister acknowledged Cambodia's effort as the Chair of ASEAN

providing support for Myanmar with regard to the implementation of the Five-Point Consensus of the ASEAN. He also reiterated that the implementation process of the Five-Point Consensus needs enough time since there are unforeseen difficulties on the ground and measures must be practical to have substantive progress. Next, H.E. Dr. Kung Phoak expressed that Cambodia will continue its supports to facilitate the implementation of the Five-Point Consensus in cooperation with the Government of Myanmar.

It is reported that the meetings were attended by the director-generals, the deputy director-generals and officials together with the Union Ministers.

First Working Committee Meeting on Cooperation in Combatting Transnational Crimes between Myanmar Police Force and Royal Thai Police Force Held



Myanmar delegation led by Deputy Minister for Home Affairs Chief of Myanmar Police Force Maj-Gen Zin Min Htet attended the first working committee meeting of the two countries' police chief level on cooperation in combatting transnational crimes between the Myanmar Police Force and the Royal Thai Police Force and related meetings which were held in Bangkok from 7 to 9 June. During the meetings, the officials discussed the following points:

- The matters relating to the prevention of cross-border crimes and transnational crimes that occurred in border areas of Myanmar-Thailand, and proper systems to exchange information as soon as possible, capacity-strengthening cooperation and MoU for the cooperation of two countries' police forces.
- The cooperation matters of the Myanmar Police Force regarding the bilateral cooperation on the investigations of illegal immigration and the offenders of human-trafficking through the border-areas.

- The detail plans of border area security and rule of law, eradication of terrorist acts, drugs, cyber-crimes, promotion of bilateral relations for border areas in the fight against transnational smuggling and cooperation works.
- The matters relating to two countries' police forces to uncover the armed groups and terrorists who are hiding in Myanmar-Thai border areas under the law because they harmed interests of both countries.

At the first working committee meeting on cooperation in combatting transnational crimes between the Myanmar Police Force and the Royal Thai Police Force, the officials of both police forces also signed six agreements for further cooperation work. Later, Myanmar delegation led by Deputy Minister for Home Affairs Chief of Myanmar Police Force Maj-Gen Zin Min Htet left Bangkok Suvarnabhumi International Airport via Myanmar Airways International on 9 June.

Statement of the Central Bank of Myanmar

The Central Bank of Myanmar released following statement describing that the use of Mobile Pay/Mobile Wallet and payment services that are not officially permitted by the Central Bank of Myanmar can lead to huge losses due to the lack of sys-

tematic supervision. If it is found to be operating without the permission of the Central Bank of Myanmar, a fine or imprisonment or both will be imposed under Section 172 of the Financial Institution Law.

Statement

1. In order to provide mobile banking services to ensure secure and efficient payment under Sections 40 and 79 of the Central Bank of Myanmar Law, Sections 5, 129 and 130 of the Financial Institutions Law, Mobile Financial Services Regulations, Mobile Banking Directives, and the Electronic Card Payment Directives, the Central Bank of Myanmar has allowed 18 banks to provide mobile banking services, ten banks for internet banking, eight banks to provide mobile payment (Mobile Pay), five institutions to provide mobile financial services, seven institutions to provide card payment services such as transportation cards and shopping cards, and four companies to provide clearance services on behalf of the seller.
2. A list of banks, financial institutions and companies that are officially permitted by the Central Bank of Myanmar are available on the official website of the Central Bank of Myanmar: www.cbm.gov.mm.
3. It is being announced on social media platforms that transferring money between users and purchases through unofficial Mobile Pay/Mobile Wallet and payment services can be made. The use of Mobile Pay/Mobile Wallet and payment services that are not officially permitted by the Central Bank of Myanmar can lead to huge losses due to the lack of systematic supervision. If it is found to be operating without the permission of the Central Bank of Myanmar, a fine or imprisonment or both will be imposed under Section 172 of the Financial Institution Law.

Statements by Health Organizations on Acts of Terrorism against Health Workers

Daw Soe Soe Aye, a midwife working at the Chantha Sub-Rural Health Centre under the Kunohn Rural Health Centre in Ye-U township, and Daw Nwe Nwe Soe, a versatile midwife working at the Linyinkyay Sub-Rural Health Centre under the Sar Taung Rural Health Centre in Sagaing township of Sagaing region were brutally killed by terrorists on 26 April and 3 June respectively. Moreover, doctors, nurses, health supervisors, midwives and support staff were killed and severely injured in the brutal and inhumane killing by terrorists.

Respective health organizations released following statements describing that they strongly condemn the aforementioned acts of terrorism -

- The Ministry of Health strongly condemns the terrorists and terrorist groups that have committed such atrocities that inflict deaths and serious injuries of the conscientious civil servants and health workers who are providing healthcare services to all national people.
- Nurse and Midwife Council is greatly displeased with such brutal killings of

nurses, midwives and health workers who are providing healthcare services to all national people and strongly condemns the terrorists who brutally kill the nurses and midwives.

- The Myanmar Nurse and Midwife Association (Central) is greatly displeased along with the bereaved families for the assassination of health workers who pose as a cornerstone of the national development and ensuring people's health and who are also serving as frontline strikers. And therefore, the Association strongly condemns any terrorist organization that brutally assassinated innocent health workers, midwives and their family members.

It is reported that the Government of the Republic of the Union of Myanmar is endeavouring to implement the peace and stability of the State, the socio-economic development of all citizens including health and fitness. In doing so, health workers are working for the citizens' health in their respective areas of responsibility across the country.

pate in future work plans of the country. A disciplined and genuine multiparty democratic system will be facilitated providing that the entire people participate in implementing it in line with “the strength of the country lies within.”

Announcement

Lessons have already been learnt from the past that unity can only assure non-disintegration of the Union and perpetuation of sovereignty for the Republic of the Union of Myanmar where various ethnic peoples are living in. In the future, it must work for the unity and solidarity of ethnic brethren. Due to the political adversaries and disagreements in ethnic affairs, internal armed conflicts occurred and it has hampered the development of the country.

Those who were persuaded by terrorist groups CRPH and NUG to commit acts of terrorism aiming towards the utter devastation of the country and launch armed resistance under various names of groups including PDF. Such doings can affect the stability of the State and also lead to delays on the way to democracy. As the strength of the country lies on its own, the entire people should cooperate in establishing a genuine and disciplined multiparty democratic system as per the Five-Point Roadmap of the State Administration Council, “upon accomplishing the provisions of the state of emergency, free and fair multiparty democratic elections will be held in line with the 2008 Constitution, and further work will be undertaken to hand over State duties to the winning party according to democratic standards, and the people participation can enhance these undertakings in line with “the strength of the country lies within” and “one of the objectives on political affairs to build a Union based on democracy and federalism through a disciplined and genuine multiparty democratic system that is fair and just”.

Therefore, it is here announced that the organizations including PDF are welcomed if they enter the legal fold for their normal civilian lives by surrendering their weapons following rules and regulations to participate in future work plans of the country.

During the ceremony, the ROC commander Brigadier General Thant Zin Oo made some remarks of enlightenment for the returnees. Then, the chairman of the Kale district administration and Kale district police commissioner shed light on the situations of community peace and stability as well as some important sections of the laws and one of the youths who returned to legal fold said the words of thanks. A Staff of WHO Office (Mawlamyine Branch) Assassinated by PDF Terrorists

The NUG, CRPH and PDF terrorist groups, based on their ideology of political extremism, are making acts of terrorism such as carrying out remote mine attacks, threats and extortions using arms, and brutal assassinations in some areas. In addition, they are also conducting threats and assassinations of health staff who are conscientiously serving the duties of public health, philanthropic organizations, NGOs and IN-GOs.

The PDF terrorists opened fire at U Myo Min Htut of 49, a staff of WHO Office (Mawlamyine Branch), using small arms on 8 June when he riding motorcycle arrived near the crossroad of No (1) Basic Educa-

tion High School, on his way back from the office. As a result, the staff died of three gunshot wounds on his neck and another one on his left collarbone. At the scene, three bullet shells of Luger and one bullet shell of SLB were found and seized.

People Defence Organization Mawlamyine has claimed responsibility for the assassination of the staff on social media. Moreover, the acts of terrorism of NUG, CRPH, and PDF terrorist groups in Mon State claimed the lives of three governmental staff and 86 people and left 12 governmental staff and 115 people injured.

The security force members are reportedly taking necessary investigations to arrest those terrorists making brutal assassinations of a staff from WHO Office serving the duties of enhancement of healthcare ser-

vices for local people of Mon State and take legal action against them under the law.

- A staff of WHO Office (Mawlamyine Branch) was assassinated by the PDF terrorists.
- The acts of terrorism of NUG, CRPH, and PDF terrorist groups in Mon State claimed the lives of three governmental staff and 86 people and left 12 governmental staff and 115 people injured.

Terrorists Fire Small Arms at Ambulance in Kyaikto Township

At 10:25 pm on 9 June, terrorists fired small arms at an ambulance which returned from the hospital in Kyaikto township of Mon state after transporting a patient to there, leaving a male dead and another male injured.

In the incident, an ambulance driven by Ko Aung Myo Thu together with Ko Nay Lin Tun of 42, Ko Pyae Phyo Aung of 27 and Ko Kyaw Zin Oo (aka) Nga Pwar transported a patient to the public hospital in Kyaikto township. On the way of returning to Sit Taung village, terrorists fired

small arms at the ambulance at the location near Ingabo village, leaving Ko Pyae Phyo Aung and Ko Kyaw Zin Oo (aka) Nga Pwar injured with gunshot wounds. While the two injured victims were being transported to the public hospital in Kyaikto township, Ko Pyae Phyo Aung died of gunshot wounds.

Terrorists are wantonly making attacks on health centres, hospitals/clinics and health staff members providing healthcare services to the public as well as volunteering staff who contribute to public healthcare services and accordingly, the entire people

Security force members are pursuing their measures in accordance with security process to identify and arrest the terrorists

who wantonly fired at the ambulance, it is reported.

Attacks of PDF Terrorists Against National Education Sector

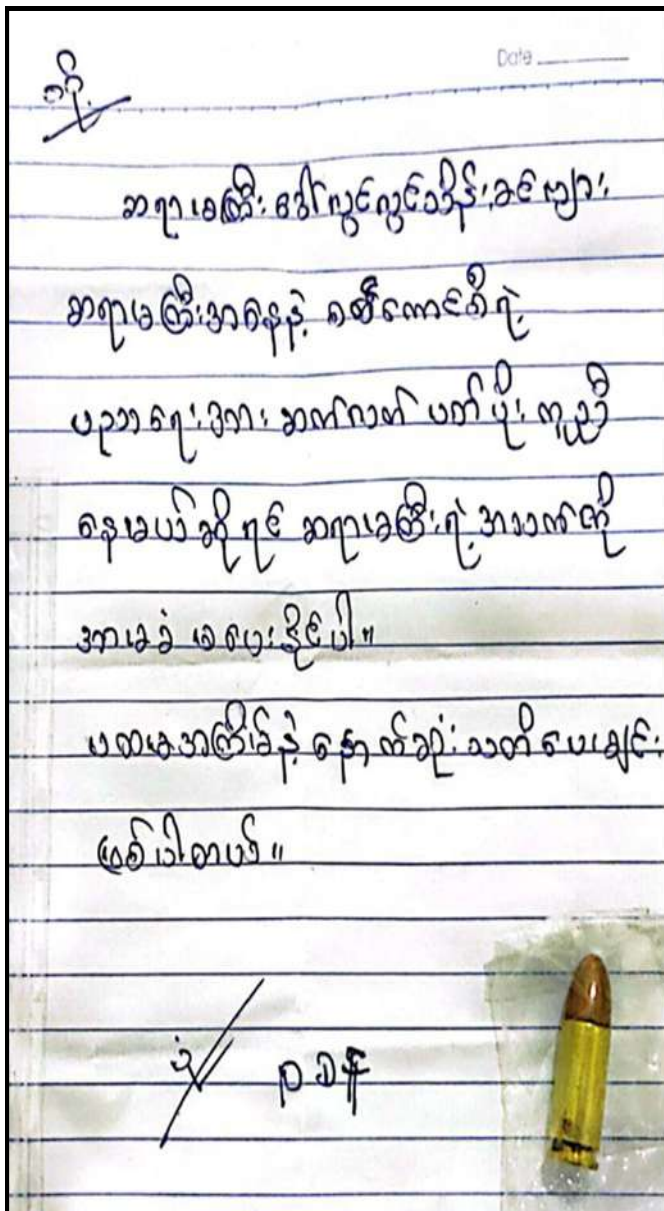
With the aims to create an uneducated society following the loss of children's rights to learning opportunity as well as to support them by making people very frightened, the NUG's subordinate PDF terrorists are making various destructive acts on education sector such as conducting intimidation and coercion of students, teachers and parents; abductions and killings of students, teachers and parents; arson and bombing attacks on educational buildings; putting textbooks and teaching/learning aids to the torch and taking those forcibly and therefore, the entire people are disgusted by ter-

ror acts of terrorists and denouncing such acts. In doing so, the terrorists' attacks on education sector which is non-military target are as follows:

- On 8 June, PDF terrorists threatened to a headmistress of Basic Education Primary School, who lives in Palaegu Village in Yebyu Township of Taninthayi Region, sending her a threat letter along with a bullet of 9MM Luger saying that **"Don't teach children, otherwise we would not guarantee your life"**.

- On 9 June, PDF terrorists with nefarious intention launched a drone attack on the Basic Education Post-Primary School (Taltheetaw) in Shwebo Township of Sagaing Region while teachers were teaching school children. The terrorists dropped homemade bombs on the school using drones. Security force members undertaking security measures near the school shot small arms at the drones, leaving a DJI-1313 drone downed and seized. During the incident, three bombs fell onto the school buildings leaving the roofs damaged.
- On 9 June, while U Chain Min, 30, a primary teacher from the Basic Education Primary School of Petap Village in Pula Township of Taninthayi Region, was teaching primary students at his house, PDF terrorists entered his house and opened fires at him leaving the teacher dead.
- On 9 June, two male terrorists riding a motorcycle threw an IED into the compound of No (1) Basic Education High School of Alal Ward in Monywa Township of Sagaing Region and then they drove away. Although the IED exploded between the Thukhawati school building and brick-wall of the school, no injury and damage were reported.
- On 9 June, it was learnt that a letter of protest was found on a table in the G-10 classroom of the Basic Education High School in Ywathitkyi Village of Sagaing Township in Sagaing Region whereas U Thet Lwin Oo, a headmaster of the Basic Education Middle School, a resident of Sanhlam Village in Launglon Township of Taninthayi Region, received a protest letter with a bullet and LLPDF logo.
- Moreover, the PDF terrorists, the subordinates of NUG terrorist group, placed the protest letters along with the bullets describing that **“to urgently stop the learning of students; threatening to education staff to join CDM campaign, and if not so, they won’t guarantee the lives and security of those education staff”** near the brick-wall of the Basic Education High School in Bokone Village of Shwegu Township in Kachin State on 9 June, near the entrances of the Basic Education Sub-high Schools in Kaninkamauk and Bellamu Villages of Ye Township in Mon State, and near the entrance of the Basic Education Middle School in Kyunchaung Village of Seikphyu Township in Magway Region on 10 June.
- On 10 June, two PDF terrorists riding a motorcycle threw one IED into No (7) Basic Education High School of Aungmingala Ward in Monywa Township of Sagaing Region and then they fled away. Although the IED explosion occurred near the entrance of the school, no injury and damage were reported.

In fact, terrorists’ intentional attacks on non-military targets of schools, teachers and students amount to War Crimes according to the provisions of Geneva Conventions and International Law. Therefore, the security force members together with conscientious people are taking necessary investigations to arrest those terrorists carried out attacks on schools at soonest.

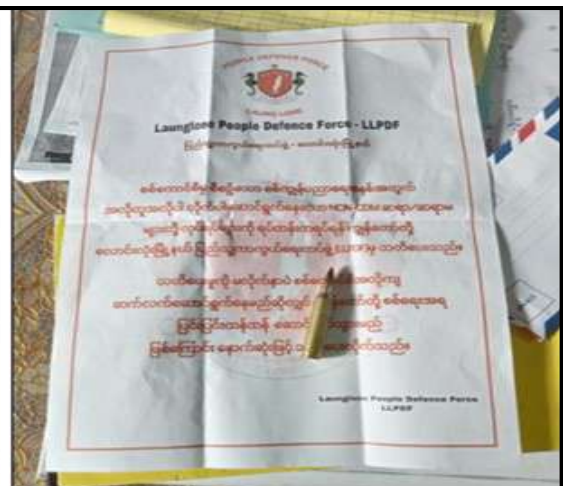

- Terrorists' intentional attacks on non-military targets of schools, teachers and students amount to War Crimes according to the provisions of Geneva Conventions and International Law.



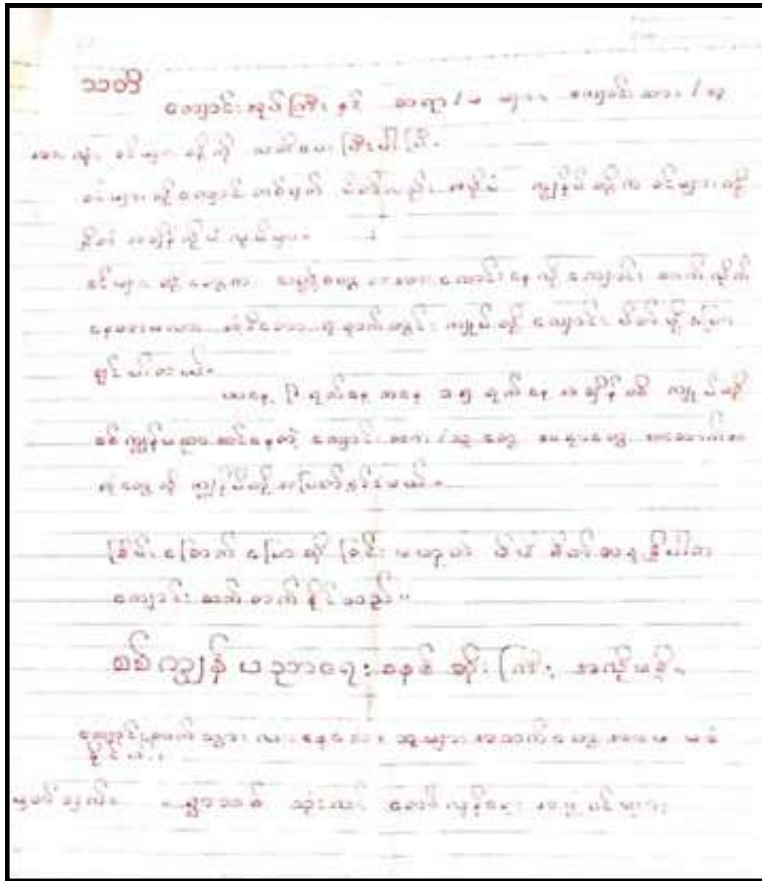

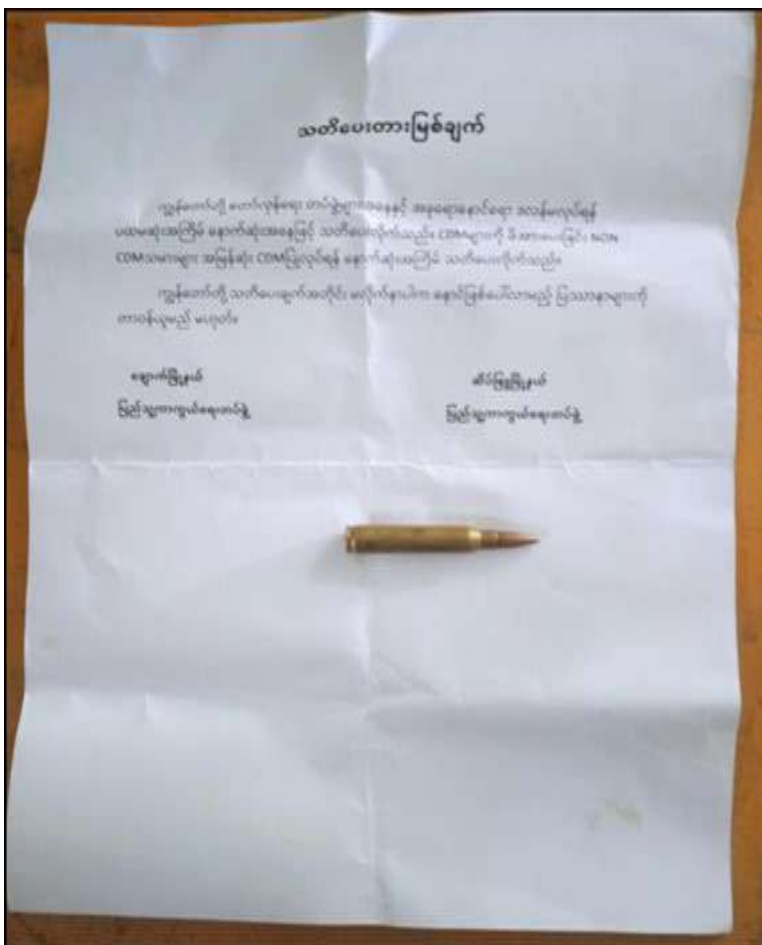

PDF Terrorists Blew up a Toll Gate Collecting Fees for Using Pakkoku-Yesagyo Road and Robbed Money as well

PDF terrorists blew up and robbed money from a toll-gate collecting road-using fees of Pakkoku-Yesagyo road near Kyauk Hlegar village in Yesagyo township of Magway region on 10 June. While five male staff and five female staff were doing their duties at the toll-gate on Pakkoku-Yesagyo, about 20 so-called PDF terrorists arrived with a car and 10 motorbikes. They took the mobile phones of the staff and made them lie faces down beside the road. After that, the terrorists shatter the window glasses of the rest-facilities of staff and then burnt it down. They also took K5 millions of collected road-using fees and blew up the toll-gate as well.

With the intents to influence the people by making them frightened and also to

disrupt the Government's administrative mechanism, PDF terrorist groups are committing the heinous crimes such as blowing up the non-military targets of public roads/bridges, carrying out remote-mine attacks against passenger bus lines. And now, they even robbed money after threatening the staff working at toll gate, and destroyed the facilities and therefore, people are very disgusted by them.

The local security personnel are now conducting block-searches to arrest and take punitive legal actions against the terrorist who committed such act of terrorism and robbery.

Terrorists groups of CRPH, NUG and PDF terrorists are conducting the acts of terrorism such as arm attacks in some areas, bombing attacks on roads and bridges and setting fire on residential houses with the aim of undermining the peace and stability of the State and the rule of law.

About four PDF terrorists set fire to shops outside the Shwekataw pagoda compound in Maha Myaing ward of Taze township of Sagaing region at 8 pm of 10 June, leaving 31 shops (worth more than 20 million kyats) destroyed in fire.

Tatmadaw personnel from local units, members of the fire brigade, departmental

officials and locals went there and attempted to put out the fire using two fire engines and two water tankers. The fire was extinguished at half past 9 pm.

It is reported that security forces are working to identify and arrest the terrorists in the above-mentioned incident in accordance with law.

Kyaw Min Yu (aka) Jimmy Convicted of Leading Acts of Terrorism in Yangon Region

Kyaw Min Yu (aka) Jimmy, the political and security adviser of the terrorist group of CRPH/NUG, who assassinated innocent people, security force members and government employees, and perpetrated bombings, was arrested on 24 October 2021 at his home in Panglong Housing Estate of Dagon Myothit (North) Township. Together with him, arms and ammunition used in their terrorist attacks and assassinations were also confiscated from the house.

The defendant Kyaw Min Yu (aka) Jimmy campaigned propaganda for the participation of government employees in the CDM movement and riots. In addition, he formed the Moon Light Operation team in April 2021 with Saw Thet Tun (a) Nay Chuu (Sky Age Education), Ko Ko Gyi (Sanchaung), Thura Kyaw (a) Nikolas, Than Aung, Ye Zarni (a) Uno (Nway Oo Gantgaw group), Kyaw Kyaw Moe (aka) Zaw Wan Maung (arrested) in order to commit terrorist activities in Yangon Region, it is reported.

- The Moon Light Operation Team managed by the defendant Jimmy carried out attacks on basic education students, teachers, and schools in Yangon Region. The Moon Light Operation Team also carried out killings on administrators, other party members and those who do not support their party, accusing them of 'informants/Dalans' in order to intimidate innocent civilians. Further, it attacked civilian targets such as power plants, government buildings, and private banks and innocent civilians.
- The fugitive offender of Lwin Ko Latt handed over arms and ammunition as well as explosives to the defendant Jimmy for making terrorist attacks by the Moon Light Operation Team.
- In addition, the Moon Light Operation team carried out terrorist attacks in Yangon in collaboration with the Yangon Urban Guerrilla-YUG led by Maung Kyaw (a) Phyo Zeyar Thaw.

- Eight large-scale terrorist mis-sions were planned to be carried out in Yangon Region, and the defendant Jimmy ordered these eight terrorist activ-ities.
- The team made an IED attack on the Basic Education Post-Primary School (Shwesandaw) in Twantay Township on 21 May 2021.
- In addition, Bo Bo and Yan Paing Hein, two terrorist members of the Moon Light Operation, were ar-rested with explosives by security forces on their way to bomb the Twantay Police Station, the 70th In-fantry Regiment and the Phayangoteto checkpoint on 7 October 2021.
- The Moon Light Operation Team made an IED attack on the Phawtkan ward administrator's office in Insein township.
- He was arrested while planning to carry out terrorist attacks, bombings and shootings in Hlegu, Min-galadon , Yankin, Dala, Thakayta, Dagon Myothit (South) and Hlaing-thaya townships.
- The defendant Jimmy provided K5.5 million to buy ammunition for the Nway Oo Gangaw group which is carrying out terrorist activities in Yangon Region.
- In collusion with the Union of Myanmar Civil Defence (UMCD), he also asked the NUG for purchasing a 3D printer capable of producing guns worth about US\$100 million.
- He repeatedly exchanged US dollars for My-anmar currency to provide financial support to terrorist groups.
- In order to provide finan-cial and technical support for launching terrorist attacks, the fugitives Yee Mon, Zaw Wai Soe, Mann Win Khine Than, Aung Kyi Nyunt, Lwin Ko Latt, Win Myat Aye, Htin Lin Aung, Moe Zaw Oo, Phyu Phyu Thin, Min Ko Naing, and Jimmy had organized Zoom Meeting weekly.

It is reported that the defendant Kyaw Min Yu (aka) Jimmy was sentenced to 'the death penalty' under Section 49 (a), 50 (i) and 50 (j) of the Counter-Ter-rorism Law on 21 January 2022 for hiding weap-ons and ammunition in his house, which are to be used by the CRPH, NUG and PDF terrorist groups declared as terrorist groups; brutal killings of innocent people in Yangon Re-

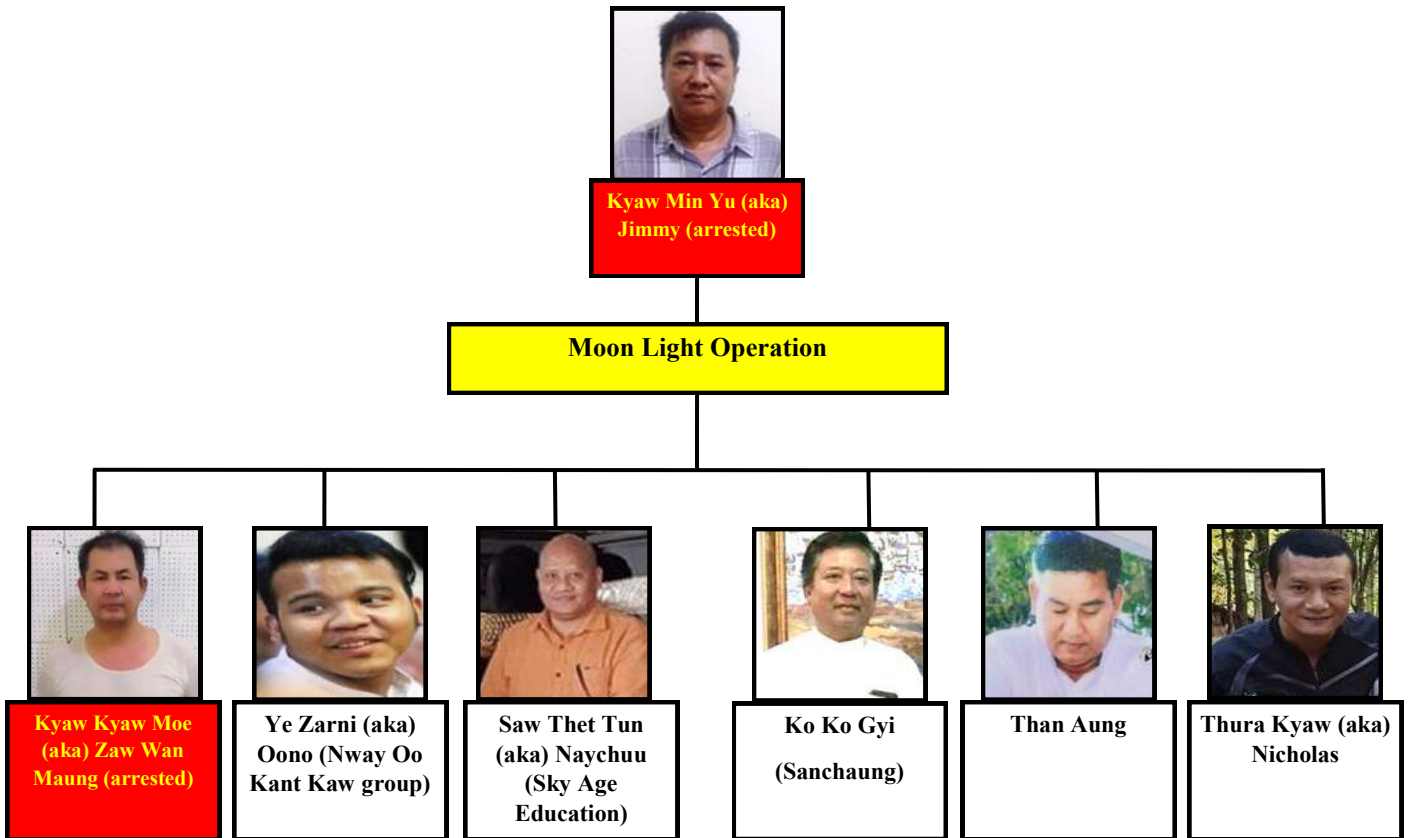

- The perpetrator Kyaw Min Yu (aka) Jimmy was arrested on 24 October 2021 at his home in Panglong Housing Estate of Dagon Myothit (North) Township. Together with him, arms and ammunition used in their terrorist attacks and assassinations were also confiscated from the house.
- The Moon Light Operation Team managed by the defendant Jimmy carried out attacks on basic education students, teach-ers, and schools in Yangon Region. The Moon Light Operation Team also carried out killings on adminis-trators, other party members and those who do not support their party, accusing them of ‘informants/Dalans’ in order to intimidate inno-cent civilians. Further, it attacked civilian targets such as power plants, government buildings, and private banks and innocent civilians.
- Eight large-scale terrorist mis-sions were planned to be carried out in Yangon Re-gion, and the defendant Jimmy ordered these eight terrorist activ-ities.
- In order to provide finan-cial and technical support for launching terrorist attacks, the fugitives Yee Mon, Zaw Wai Soe, Mann Win Khine Than, Aung Kyi Nyunt, Lwin Ko Latt, Win Myat Aye, Htin Lin Aung, Moe Zaw Oo, Phyu Phyu Thin, Min Ko Naing, and Jimmy had organized Zoom Meeting weekly.
- The defendant Jimmy was sentenced to ‘the death penalty’ under Section 49 (a), 50 (i) and 50 (j) of the Counter-Ter-rorism Law on 21 January 2022 for hiding weap-ons and ammunition in his house, which are to be used by the CRPH, NUG and PDF terrorist groups declared as terrorist groups; brutal killings of innocent people in Yangon Region; close plan-ning and directing terror-ist attacks and funding to terrorist groups by exchanging US dollars for Myanmar currency several times.

As a result of the combined efforts of the security personnel and conscientious people who can no longer tolerate the terrorist bombings and brutal assassinations of innocent civilians, civil servants and securi-

ty force members, NUG member terrorist Maung Kyaw (aka) Phyo Zeyar Thaw was arrested with arms and ammunitions at the Yadana Hninsi Housing, in Yadana Road of Dagon Seikkan Township on 18 November

2021. According to his confession, the police raided his houses located in in Thingangyun Township and seized a total of 178 guns and explosives.

According to the confession of Maung Kyaw (aka) Phyo Zeyar Thaw, it is found out as follows –

- NUG members Yee Mon and Lwin Ko Latt transported 353 various arms, 476 magazines and various kinds of ammunition and explosives to launch terrorist attacks in Yangon Region.
- Defendant Maung Kyaw (aka) Phyo Zeyar Thaw gave weapons provided by NUG to 20 terrorist groups to launch attacks on innocent civilians in Yangon Region.
- They also killed the townships/wards/ townships administrative officials, government employees, USDP members and other opposition party members and innocent civilians and also launched bombing attacks on government-owned buildings 30 times while 32 times on ward administration offices, nine times near EPC offices, nine times near the RTAD office, five times on CCTV control boxes, 60 times at public areas to threaten the people, two times near reli-

gious buildings and three times on schools. In doing so, they gave weapons depending on the missions.

Defendant Maung Kyaw (aka) Phyo Zeyar Thaw led and manipulated 20 terrorist groups formed using various names in Yangon city. He then provided required arms and ammunition to the terrorist groups to kill innocent people. The groups committed the assassinations of innocent people for 28 times.

- On 29 April 2021, as HRD terrorist group attacked Hlinethaya Township administrative office in No (16) ward leaving one was injured.
- As the result of the acts of terrorism committed by the STF terrorist group from April to October 2022, three innocent civilians and a security personnel were killed while other three civilians and four security personnel were injured. The terrorist group also robbed a goldware shop and was also ordered to rob a KBZ sub-bank and open fire to a police security outpost.
- As the result of the acts of terrorism committed by PDF terrorist groups in respective townships of Yangon Region from April to October 2022, eight inno-

cent civilians and six security personnel were killed and two civilians injured.

- Due to the acts of terrorism committed by RF terrorist groups from April to October 2022, an innocent civilian was assassinated while a security personnel was killed and another one was injured.
- YG Network terrorist group opened fire to the Shwepyitha township No (6) ward administration office leaving two innocent civilians injured.
- UMCD terrorist group shot security members in front of the Myanmar Economic Bank located Thamadi road, Mtyitta Nyunt ward in Tamway Township leaving one member dead.
- YFA terrorist group assassinated U Thein Aung, Mytel GM in Mayangon Township.
- Defendant Maung Kyaw (aka) Phyo Zeyar Thaw testified that CRPH and NUG members Phyu Phyu Thin, Naing Htoo Aung, Win Myat Aye and Lwin Ko

Latt transferred money which was collected using various ways to him to launch attacks.

- He spent money on buying arms and ammunition, explosives, unregistered vehicles, renting safe houses, committing bombing attacks and giving cash awards depending on the mission of killing people and he also used it for his own sake.

Since Maung Kyaw (aka) Phyo Zeyar Thaw was found guilty for keeping the arms and ammunition at his houses, for CRPH, NUG and PDF which were declared as terrorist groups, launching bomb attacks in Yangon by leading 20 terrorist groups, instructing to attack security outposts, police stations, departmental offices and stations, kill the innocent civilians, he was convicted by Martial Law tribunal and sentenced to the death sentence under the Counter-Terrorism Law Section 49 (a), 50 (i) and 50 (j) on 21 January 2022.

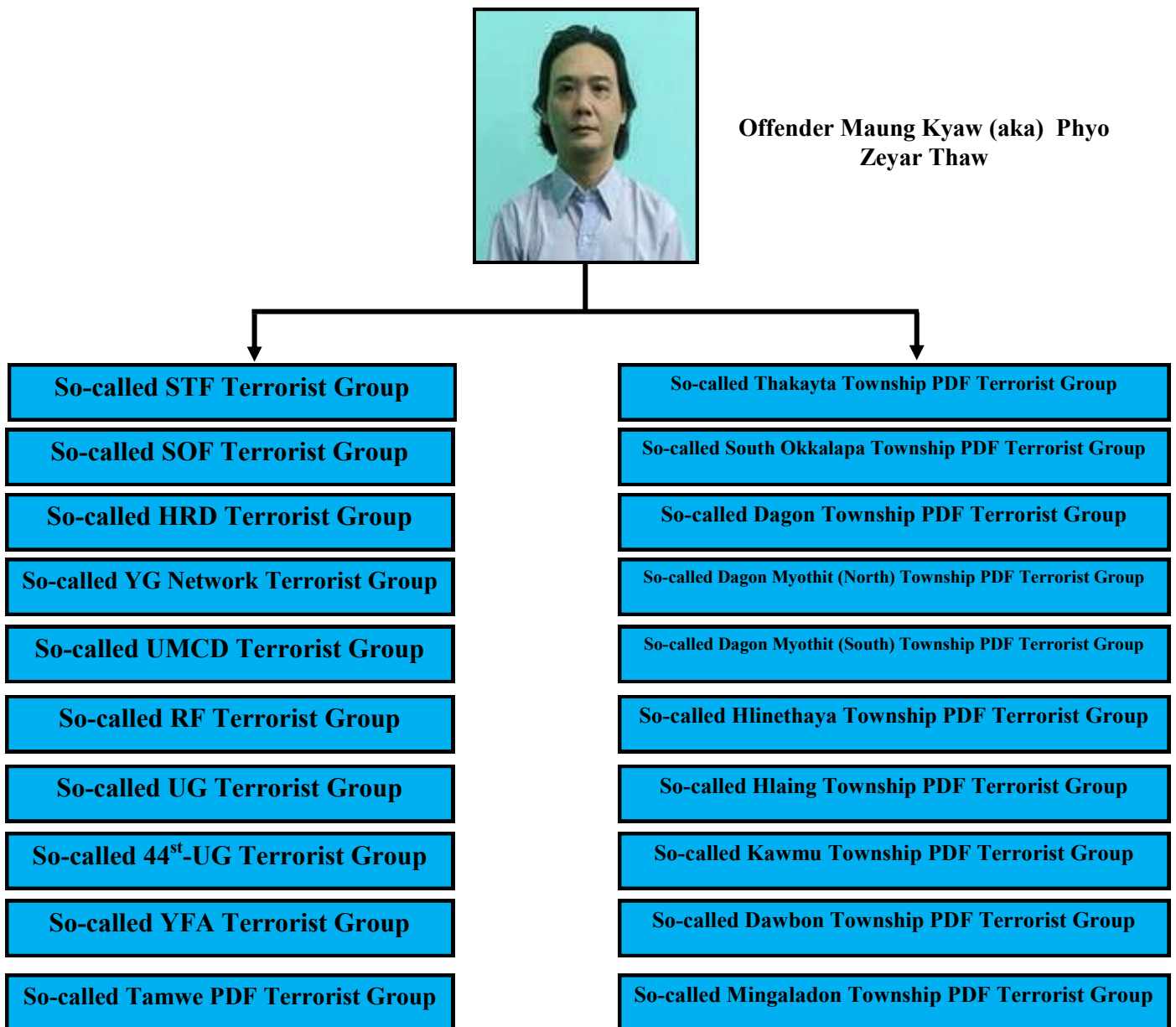

Criminals Convicted of Brutal Killing of an Innocent Female Civilian Living in Aung Myittar Ward in Hlaingthaya Township

On 14 March 2021, some 20 people led by Hla Myo Aung (aka) Ko Myo (aka) Wat Gyi carrying sticks and knives arrived at a woman's home and accused her of informant/Dalan for not banging pans and pots. They then abducted her for interrogation. The news report on the arrest of the perpetrator Hla Myo Aung (aka) Ko Myo (aka) Wat Gyi was already described in the newspapers issued on 16 and 22 March 2021.

According to the confessions of the arrested perpetrator Hla Myo Aung (aka) Ko Myo (aka) Wat Gyi -

- At 9 PM on 14 March 2021, some 20 people living in Aung Myittar ward, including Myint Myint Aye, Tin Tun Aung (aka) Moe Shan, Thant Zaw Oo and Min Min (aka) Aung Min Oo, led by Hla Myo Aung (aka) Ko Myo (aka) Wat Gyi made barbaric tortures on a female civilian and a housemaid after they tied their hands behind their backs, accusing them of informant/Dalan for not banging pans and pots.
- On 15 March, Hla Myo Aung (aka) Ko Myo (aka) Wat Gyi and Aung Thura Zaw (aka) Gatone (aka) Thura took the innocent female civilian to a location near Byoukyoe village in Twantay township

by car after confining the housemaid at home. Arriving at a deserted area, they then stabbed her for five times with a nine-inch-long double-edged dagger taken with them. While the innocent female civilian was struggling against them with the stab wounds, Aung Thura Zaw (aka) Gatone (aka) Thura took off her a gold necklace with locket and a gold ring she wore. Then he took her down from the car and stabbed her brutally again for two times to the death. After that, they left the body of the innocent female civilian into bushes.

As regards the crime, the criminals: Hla Myo Aung (aka) Ko Myo (aka) Wat Gyi, Aung Thura Zaw (aka) Gatone (aka) Thura, Tin Tun Aung (aka) Moe Shan and Myint Myint Aye, who made several barbaric tortures on and killed an innocent female civilian brutally after they accused her of 'informant/Dalan', were faced trials by the military tribunal of Martial Law. As the criminals were found guilty, they were sentenced to 'the death penalty' under Section 302 of the Penal Code on 12 April 2021, it is reported.
