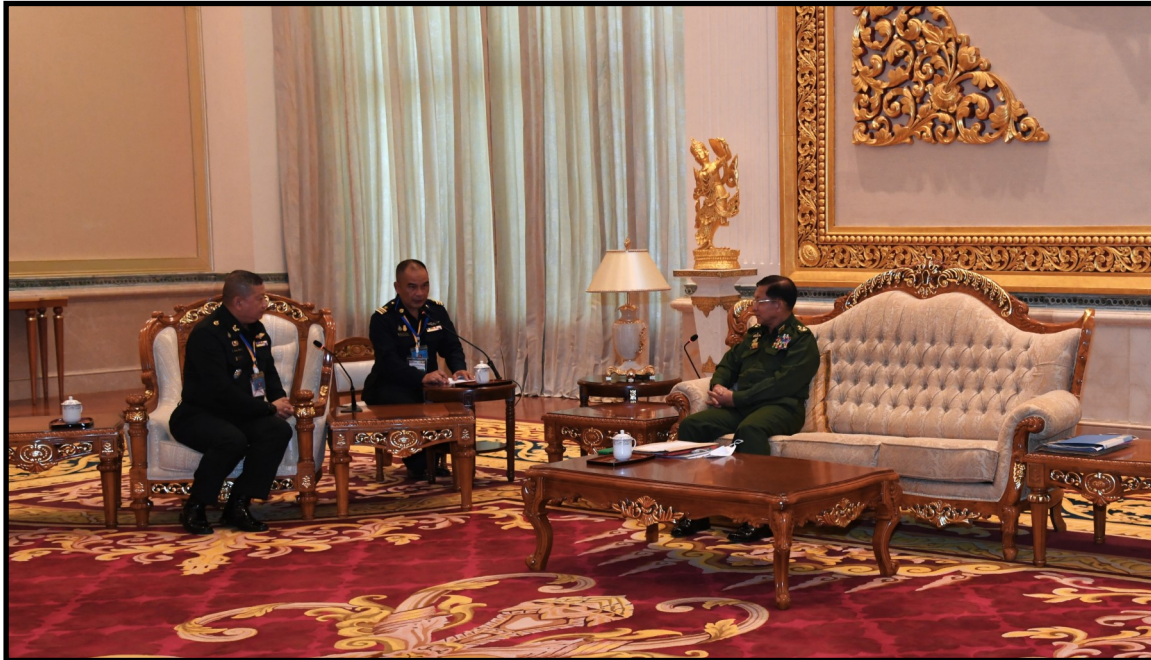

Apichet Suesat from the Royal Thai Armed Forces, who attended the 34<sup>th</sup> Myanmar-Thai Regional Border Committee (RBC) Meeting hosted by Myanmar, at the parlor of the Zeyathiri Beikman in Nay Pyi Taw on 29 June.

During the meeting, they discussed the following matters:

- The matters to be continued to strengthen the existing bilateral relations and co-operation between the two armed forces, and the cooperation to be strengthened on peace and stability, rule of law, the measures of anti-narcotic drugs and other related sectors in border areas.
- The matters relating to the political transitions in Myanmar and efforts made by security force members to combat terrorist acts.

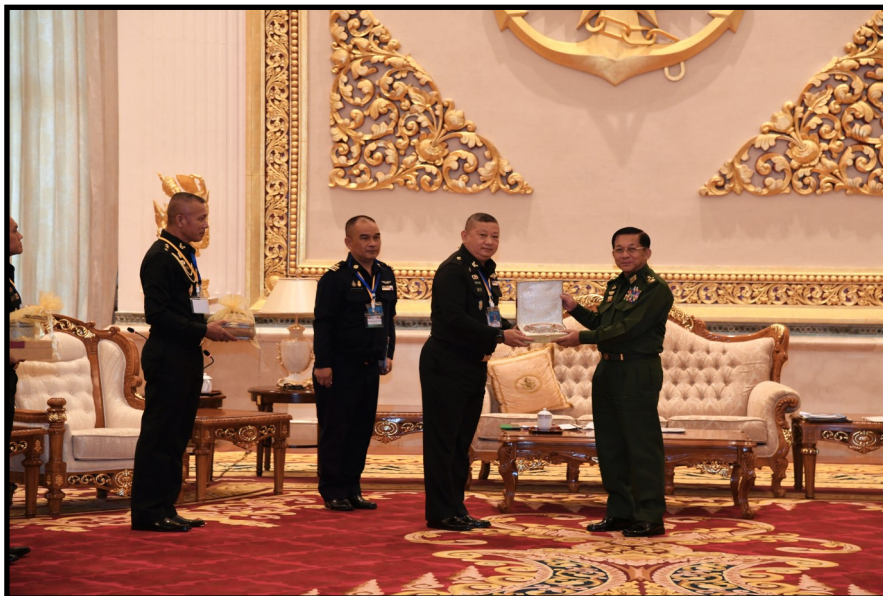
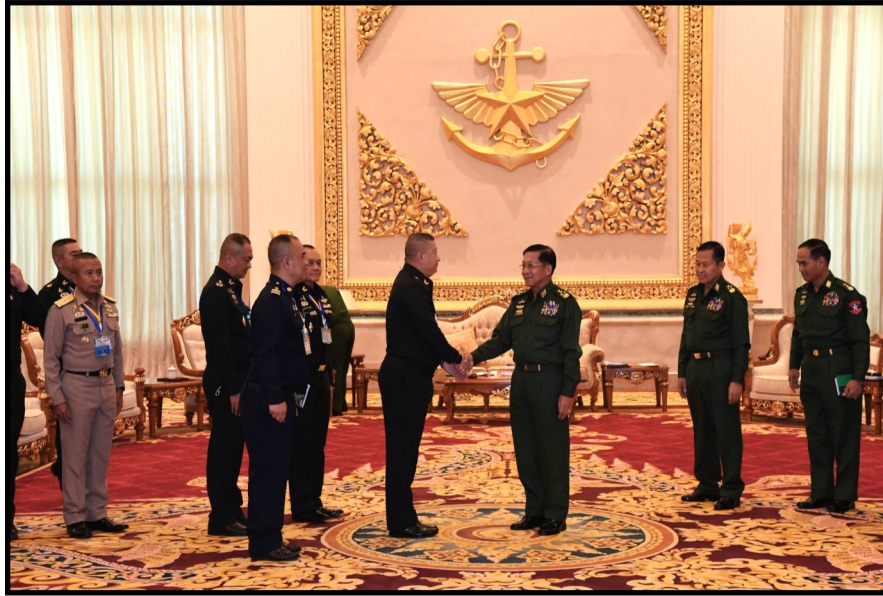

## Vice-Chairman of State Administration Council Deputy Prime Minister Vice-Senior General Soe Win Addresses the 3/2022 Meeting of Illegal Trade Eradication Steering Committee



The Illegal Trade Eradication Steering Committee held work coordination meeting 3/2022 at the meeting hall of the Ministry of Commerce in Nay Pyi Taw on 28 June. During the meeting, Chairman of the Illegal Trade Eradication Steering Committee Vice-Chairman of the State Administration Council (SAC) Deputy Prime Minister Vice-Senior General Soe Win stressed the following points:

- After the reconstitution of the Illegal Trade Eradication Steering Committee, the estimated value of illegal goods seized between January and May 2022 was about K21.771 billion, which was K13.318 billion more in estimate value when compare with that of the entire previous year.
- In April 2022, about K5.233 billion worth of illegal goods was seized but in May only K3.633 billion worth of illegal goods were confiscated. Therefore, about K1.6 billion worth of seized illegal goods was less than the seizures in April 2022.
- There was a shortage of K1 billion in the seizures of special teams of regions and states after analysing those shortage.
- Moreover, Yangon International Port and Yay Pu permanent inspection gate saw a decline of over K0.721 billion in the estimated value of seizures. Hence, the personnel of the region and state anti-illegal trade special task forces, the customs department and one-stop services (OSSs) are urged to implement their work plans more effectively.
- In some regions and states, all possible means should be applied to control illegal trade along the trade routes.
- Regular or surprise checks should be carried out at the places where illegal trade starts and illegal goods are stored for distribution and action must be taken.
- Systematic checks should be made on illegal goods as well as restricted goods.
- The confiscat-ed goods must be sold as quickly as possible in accordance with the rules and regulations to increase the government's revenues.
- Loss of the seized goods before auction will be nonsense to those who confiscat-ed them, and the State revenues will de-



crease as well.

- So, the seized perishable goods must be auctioned as quickly as possible in accord with the procedure. Moreover, the seized licensed and unlicensed vehicles must be handed over in accord with the law and procedures and their cases must be settled.
- The members of the Illegal Trade Eradication Steering Committee and all those involved in anti-illegal trade to strictly follow the policy, rules and regulations,

notifications by the government and action must be fair and under the law.

The meeting was attended by Union Minister U Win Shein, deputy ministers, Nay Pyi Taw Council member, the Chairman of Revenue Appellate Tribunal, permanent secretaries, directors general and officials. Officials from regions and states attended the meeting through videoconferencing.

According to their own accounts, they are not able to return to the legal fold due to the coercion and threats of the CRPH and NUG terrorist groups.

## Myanmar Delegation Attends Intersessional Meeting of Anti-Personal Mine Ban Convention 2022



Myanmar delegation led by U Aung Kyaw Moe, the director-general of Resettlement Department of the Ministry of Social Welfare, Relief and Resettlement attended the Intersessional Meeting of the Anti-Personal Mine Ban Convention held in Geneva, Switzerland from 20 to 22 June.

At the meeting, provisions to mine-injured persons of APMBC State parties; implementation of Oslo Action Plan, the matters on Making Every Effort Count: Towards a Successful 2025 and Fostering Cooperation for Rehabilitation as well as important matters on implementation of AP-MBC including elimination of anti-personal mines.

The Myanmar delegation led by the director-general U Aung Kyaw Moe discussed the following points:

- Regular coordination meetings have been held after work committees on

mine risk were formed in Nay Pyi Taw, Kachin state, Kayah state, Kayin state, Shan state (North) and Rakhine state.

- Since 2017-2018 FY, persons injured due to anti-personal mines have been provided at the rate of 200,000 kyats per person. So far, 138.8 million kyats in total have been provided to 694 mine injury victims.
- Efforts on rights for persons with disabilities are under way in pursuant to UNCPRD.

## 36<sup>th</sup> ASEAN Heads of Specialist Anti-Trafficking Unit-HSU Meeting Held



The 36<sup>th</sup> ASEAN Heads of Specialist Anti-Trafficking Unit-HSU Meeting was held through videoconferencing on 28 June. The leader of the Cambodian delegation, who is the Chairman of the meeting, delivered an opening remark.

During the meeting, Commander of the Anti-Trafficking Police Force of the Myanmar Police Force, Police Brig-Gen Myint Htoo, explained Myanmar's Anti-Trafficking efforts as follow:

- The Anti-Trafficking Law enacted in 2005, which is the most important part of the policy and cooperation, was amended in consultation with relevant government departments and organizations and local and international legal experts to be in line with the international standards. A new anti-trafficking law was enacted on 16 June this year to effectively prosecute child trafficking.
- At the 14<sup>th</sup> Coordinated Mekong Ministerial Initiative against Trafficking-

COMMIT and Regional COMMIT Task Force meetings, the matters related to formulation of the National and Cross-Border Referral Mechanism and the extension of the Sub-Regional Plan of Action 2014-2018 (SPA IV) were discussed.

- The respective ASEAN member States briefed their efforts to combat human trafficking, HSU Action Plan (2022-2023) (Draft) and the hosting of the 37<sup>th</sup> Meeting of ASEAN Heads of Specialist Anti-Trafficking Unit-HSU Meeting by Indonesia.

The meeting was attended by representatives led by Commander of the Anti-Trafficking Police Force of the Myanmar Police Force, Task Force leaders and representatives from Brunei Darussalam, Cambodia, Indonesia, Laos, Malaysia, the Philippines, Singapore, Thailand, and Viet Nam, and representatives from the ASEAN Secretariat.

## Plans are Underway to Fulfill the Housing Necessity for Active and Retired Civil Service Personnel, as well as Ordinary People



Deputy Minister for Construction U Win Pe accompanied with officials from the ministry inspected the implementation of housing projects in the Yangon region and the work process of the Department of Urban and Housing Development on 26 June. During the tour, the officials concerned presented the necessities.

Deputy Minister highlighted the following points in response of their reports:

- In order to develop the urban sector, the State is implementing the affordable housing projects with an aim to fulfill the housing necessity for active and retired civil service personnel, and ordinary people. Moreover, it is necessary to renew the old housing projects for the improvement of living standards in Yangon area under re-development plans.
- Finding good ways to make long-term

investment for private entrepreneurs and finding job opportunities for the local people.

Under the State Administration Council government, the construction of civil service personnel's rental housings for the fiscal year 2020-2021 incumbent government were carried out with the aim of providing comfortable living conditions for civil service personnel during their service and retirement. There are 144,006 rooms in total including 19,825 staff housing units constructed by the Department of Urban and Housing Development and 124,181 staff housing units constructed by the Departments in regions and states. It is reported that the civil service personnel who are allowed to live in the rental housings will have to pay 13,800 kyats per month for officer level and 5,400 kyats for staff level.

## Progress of COVID-19 Vaccination in Respective Regions and States



Covishield COVID-19 vaccination processes as booster dose in Nattalin Township

The Ministry of Health has carried out COVID-19 prevention and control activities in respective regions and states by designating targeted groups and accordingly, vaccination process is being accelerated-

- 1.53 million students aged from five to 18 years, 0.11 million students aged from 15 to 18 and 26.36 million students aged 18 years and above have already received two-time full doses of the COVID-19 vaccine.
- 3.56 million students aged from five to 18 years, 0.14 million students aged from 15 to 18 and 3.5 million students aged 18 years and above have already received the first doses.
- A total of 2,961,680 people have been vaccinated against COVID-19 as booster doses in respective regions and states from 1 January to 27 June 2022.
- As of 27 June, 35.2 million people in total have been vaccinated against COVID-19. About 28 million people have received two-time full doses of the vaccine, 7.2 million people have received the first doses and 2.9 million people have been vaccinated against COVID-19 as booster doses. A total of 66.1 million people have been inoculated against COVID-19 in Myanmar.

The Ministry of Health is conducting COVID-19 tests regularly, 12 new cases of COVID-19 were detected from testing a total of 4,922 samples accounting for 0.24 percent on 27 June. As of 27 June 2022, a total of 613,568 cases were detected from testing a total of 8,355,530 samples and death-toll reached 19,434.

## Political Extremist Conduct Threats of Violence against Opening of Basic Education Schools



Sound mine explosion took place near the brick-wall in front of the Basic Education High School of Mya Taung Village in Tigyaing Township

With nefarious intentions to create uneducated classes in society following loss of children's rights to education as well as to strike terror into students; teachers and parents, NUG terrorist group and its affiliated terrorists of political extremists are writing threat of texts and hanging up threatening letters at schools and mounting bomb attacks on school building. Their doings are as follows:

- On 27 June as terrorists carried out an improvised sound bomb attack at the spot near the brick fence at the frontage of the Basic Education High School in Mya Taung village of Htee Gyaing township, Sagaing region. The school has 196 students.
- On 27 June, terrorists wrote threat of texts at the Basic Education High School in Htan Thone Bin village of Myan Aung township, Ayeyawady region. Acting on information received, security force members inspected the scene and spotted threat of texts written with piece of brick

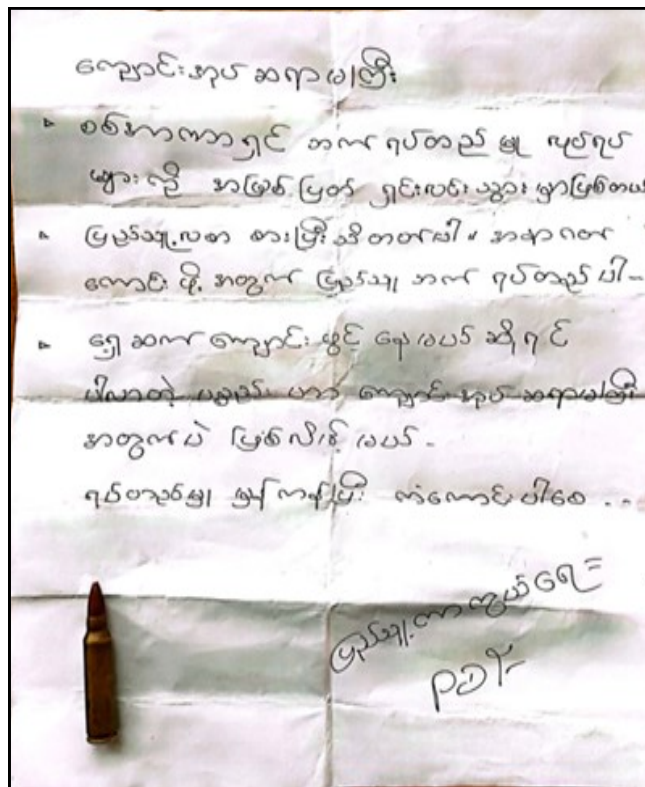
on the concrete walkway in front of the school staff room in the school area and they removed those texts.

- On 28 June, a white plastic bag, in which a threatening letter and a bullet were put, was found at the spot near the fence of Daw Myint Myint Sein of 53, a school headmistress of Nyin Htwe Basci Education High School in Nyin Htwe village of Yebyu township in Taninthayi region. Acting on information received, security force members inspected the scene and seized those.

Security force members taking necessary measures continuously to identify and arrest the terrorists, also political extremists, who made threats of violence against students, teachers and parents in order to make them frightened and not to open schools.

### Innocent Civilians Injured in Explosion of an IED Planted by PDF Terrorists in Chaung-U Township on Monywa-Mandalay Road

The NUG's affiliate PDF terrorist groups are committing the crimes of blowing up the public roads, streets and departmental offices with the intent to inflict damages to the people living in peaceful environment and the security officials discharging the duties of law enforcement.

In this regard, on 27 June, two innocent civilians from Monywa township and one from Chaung-U township riding motor-bikes were injured in the explosion of an IED planted by PDF terrorists on the Monywa-Mandalay road between mile-marks 70 of one furlong and two furlongs. The victims are: Maung Pho Chae, 17 (s/o)

U Zaw Khin and Ma Tin Win Khaing, 17 (d/o) U Nyo Win from Aung Chan Tha ward of Monywa township and Daw Khin Nyein Myat, 29 (d/o) U Win Ko living in Chaung-U North ward of Chaung-U township.

In the aftermath of the IED explosion, Daw Khin Nyein Myat got splinter wounds on her right forehead and calf; Maung Pho Chae got two injuries of fractures on his left thigh and bruise on his left knee; and Ma Win Win Khaing got splinter wounds on left thigh, on her back-head and a fracture of her leg. The injured victims are now taking medical treatments in Chaung-U public hospital.

The PDF terrorists are committing the inhumane crimes of planting mines and IEDs in the crowded public areas including roads and bridges which are non-military targets. Therefore, people are denouncing such acts and willing others to protest against such acts of terrorism.

It is reported that security forces continue necessary actions to arrest the terrorist groups who planted the IED on the public road.

## **Improvised Mortar Shells Fired by PDF Terrorists Hits Civilian Houses in Tilin Town**

On 26 June, PDF terrorists fired improvised mortars at Tilin town of Magway region and the mortar shells hit U Aung Than Win' house located in the ward (1), leaving himself, his wife Daw Kyi Tin and his daughter Yamin Ei with shrapnel wounds. Although the injured victims were transported to the Tilin public hospital, all of them died of the injuries.

With the intents to paralyze the Government administration mechanism as well as to disrupt the State's peace and stability, terrorists of political extremists are firing small arms and support weapons at non-

military targets of towns and villages where innocent civilians live, and carrying out bomb attacks on public areas, buildings as well as roads and bridges. The entire people are disgusted by their acts of terrorism since such violent attacks are the inhumane acts of terrorism claiming the lives of people and inflicting damage to their property.

It is reported that local security force members continue necessary measures to identify and arrest the terrorists who fired improvised mortars at non-military targets of towns and villages.

## **An Explosion Takes Place in an Attempt to Set up IEDs for Purposes of Terrorism**

On 26 June, an explosion took place in the room (402) of No (16) building on A (10) street of Dagon Myothit (Seikkan) township. When security force members arrived there to make further investigations, Kaung Thant of 18 who ran along the A (10) street and Aung Aung of 24 were arrested. Of these two, Kaung Thant, who lives in the Myaseinyoung ward of Htantabin township, was found laceration in his left and right hands, and Aung Aung, who lives in the Nwe Aye ward of Dawbon township, with wounds in his face, chest, shoulders, left hand and leg.

According to the confessions of arrested terrorists, it was reported that the explosion took place while Kyaw Swar together with them were setting up IEDs in

the room for the purposes of terrorism leaving Kyaw Swar dead and two of them were injured. When security force members inspected the room, they found Kyaw Swar dead with shrapnel wounds all over the body. Furthermore, security force members also found an unexploded IED made with PVC pipe, connecting with a keypad phone and two dry cell batteries, and they deactivated and seized it.

Terrorists upholding the extreme dogma did short-course trainings for setting up and planting IEDs in EAOs area and via online applications and websites. Since the terrorists do not have sufficient skills on IEDs, frequent explosions have occurred during their attempts to set up IEDs claiming their lives. It is found out that 45 terror-



ists were killed and 36 were injured so far in IED explosions.

The two arrested terrorists were transported to the public hospital in the North Okkalapa township for medical treat-

ment. Security force members are also taking necessary measures to identify and arrest other associates involved in the accident and take legal action against them.

### **Offenders Dead and Injured in an Attempt to set up IEDs in the Building to carry out Acts of Terrorism**

- An explosion took place in the apartment room of Dagon Myothit (Seikkan) township while three terrorists were setting up IEDs for the purposes of terrorism, leaving one terrorist dead and other two injured.
- Frequent explosions have occurred during the terrorists attempt to set up IEDs claiming their lives. It is found out that IED explosions have claimed the lives of 45 terrorists and left 36 injured as of today.

### **Terrorist Members of so-called Burma Final Revolution Armed Force-BFRAF Carrying out Acts of Terrorism in Yangon Region Arrested**

As the government is taking necessary measures to prevent terrorist bombings and killings of innocent civilians in Yangon Region, seven terrorist members of so-called Burma Final Revolution Armed Force (BFRAF) including Ye` Naung Tun (aka) Demon were arrested from 8 April to 26 June according to the tip-off by conscientious civilians who do not want destructive acts.

According to the confessions of the arrested offenders, when 11 terrorist members of the so-called BFRF Shu Maung Maung Aung and Thin Yanant Hlaing (living together with him), Htet Lin Naing and Aye Thiri Moe (living together), Wai Yan Phyoe and Zun Pwint Khin Oo (living together), Kyaw Zin Thein and Phyu Phyu Thwe (living together), Kaung Set Thu and Khin Thandar Lwin (living together) and Wai Yan Moe Oo (aka) Jimmy were drink-

ing at a party at the apartment in Shwepyitha Township in the evening of 26 June, they were arrested along with related explosive devices.

In the incident, a total of 18 offenders including 13 males and 5 females were arrested together with one Sig Sauer Pistol and one magazine of it, 50 rounds of .380 bullet, 75 homemade mines, two walkie talkies, three 5-gallon acid buckets, two 2-gallon acid buckets, one keypad phone and other related explosive devices.

The movements of the arrested offenders are as follows:

- Ye` Naung Tun (aka) Demon and Ye` Min Hein (aka) Ye` Phyo Aung (aka) Ye` Gyi had attended terrorist explosive training for seven days at the first week of June 2021 organized at Laiza, the KIA headquarters. Then, Ye` Naung Tun (aka) Demon, Ye` Min Hein (aka) Ye` Phyo Aung (aka) Ye` Gyi, and Yan Naing Htoo (aka) Nagarlay formed the so-called BFRAP with 15 terrorist members, and received necessary finances and explosive devices to carry out terror acts from CRPH and NUG terrorist groups.
- Shu Maung Maung Aung attended terrorist explosive training in KLNA bri-

gade area (3), and Wai Yan Phyo, Wai Yan Oo (aka) Jimmy and Khin Thandar Lwin attended a place of jungle for one month.

It was learnt that the so-called BFRAP terrorist group committed 11 terrorist bombings on public areas in Yangon Region as follows:

- They conducted IED attack on No (1) Myoma Police Station of Thakayta Township on 7 September 2021.
- They carried out another IED attack on Ward Administrative Office of Hninsikone (a) ward in Thingangyun Township on 20 September 2021.
- An IED explosion occurred at the corner of Zeyathukha and Thapyaynyo streets at No (25) ward in Thingangyun Township on 30 September 2021.
- Another IED explosion happened at Thinbaw Kyin bus stop near township customs office in Dawbon Township on 1 October 2021.
- They committed an IED attack on Township Development Office located on Myintawthar Road in No (5) ward of Thakaytha Township on 25 December 2021.
- They carried out an IED attack on Ky-

- They threw an IED to Thinbaw Kyin Police Station in Dawbon Township on 5 January 2022.
- They threw another IED to Township Electricity Office in Thakaytha Township on 6 January 2022.
- An IED explosion occurred at Yan Aung Ward of Thakaytha Township on 1 February 2022.
- They carried out two IEDs attacks on entrance gate to “War War Win” construction co.,ltd. in Hlinethaya Township on 6 April 2022.
- They threw IED to a vehicle stopped at

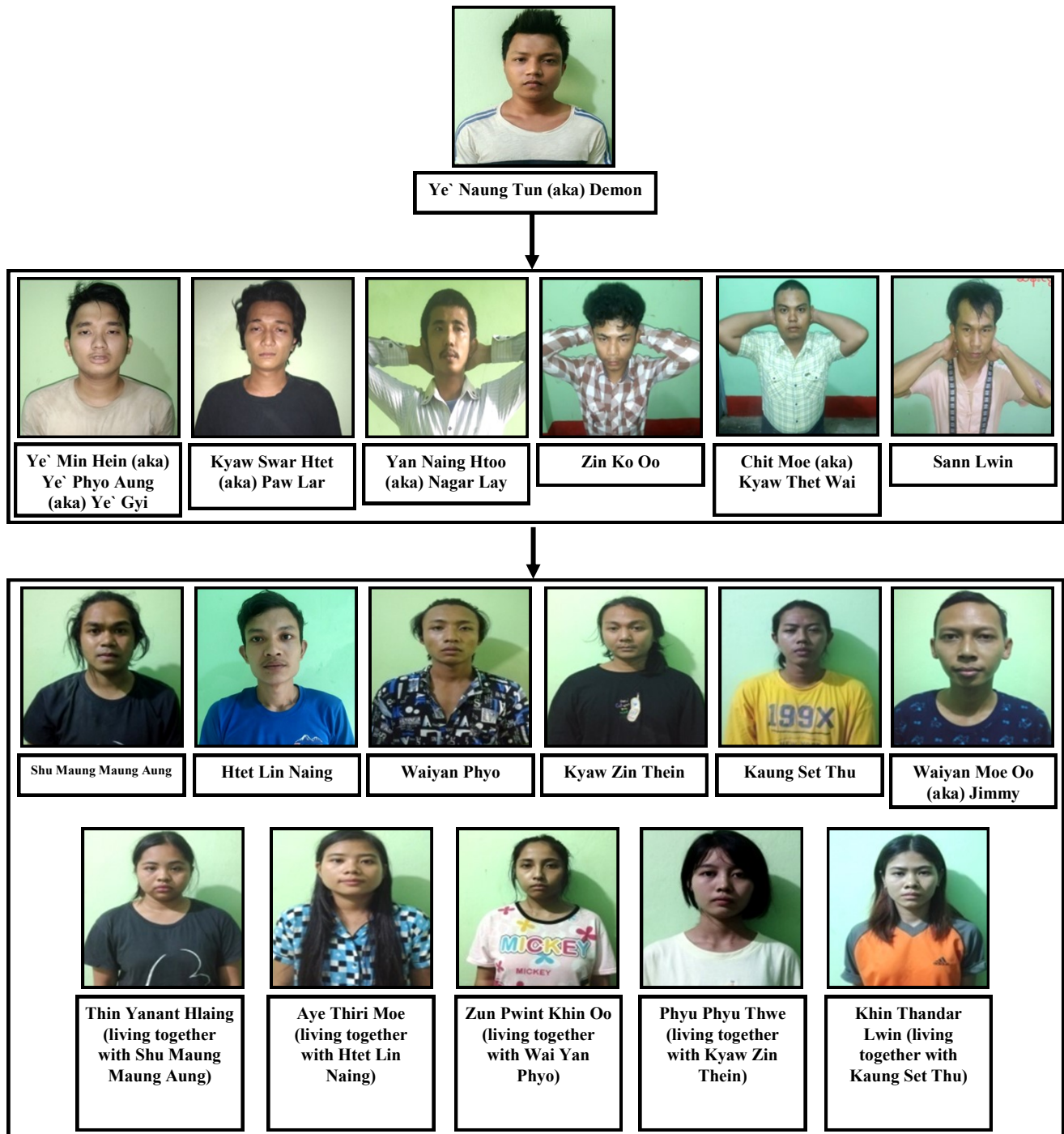
YBS (56) bus station beside Thakhin Mya park of Ayeyawady ward in Ahlone Township on 6 April 2022.

Therefore, the relevant security force members are taking necessary investigations to take effective legal action against those arrested offenders.

## Diagram Showing the Relation of Arrested Terrorist Members of BFRAF Carrying out in Destructive Acts in Yangon Region

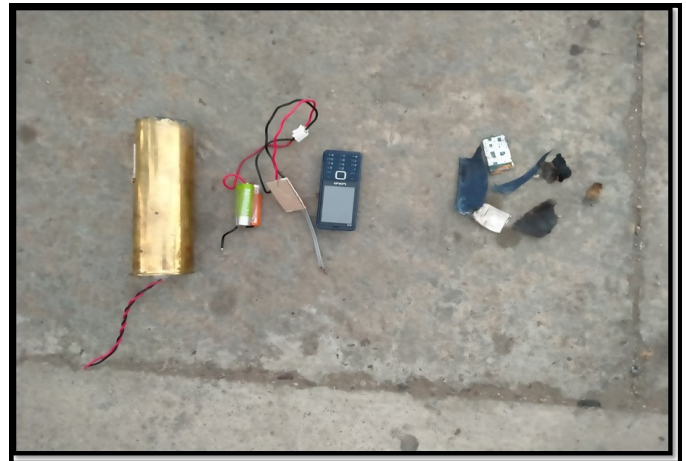

## Suspects Involved in the Robbery Case at KBZ Bank (Branch 9) in Chanayetharzan Township Arrested



The robbery of KBZ Bank (Branch 9) located on 26<sup>th</sup> street, between 62<sup>nd</sup> street and 63<sup>rd</sup> street in Pyigyimyatmhan ward of Chanayethazan Township on 17 June 2022 at the scene

On 16 June, six terrorists from so-called Yadanarphone Revolution terrorist group robbed the No. (9) branch of Kanbawza Bank located at 26<sup>th</sup>, 62<sup>nd</sup> x 63<sup>rd</sup> in Chanayethazan township of Mandalay region and took K44.9 million at gunpoint. Due to the relentless efforts of the security force members to arrest the perpetrators as early as possible, the six culprits: Kaung Khant Naing, Than Tun Zaw, Myo Min Thant, Pa Pa Lin, Thinzar Lin and Lae Lae Wai were arrested in No. (1) ward of Nyaung-U township on 22 June.

According to the confessions of the arrested perpetrators,

- Six perpetrators including Kaung Khant Naung and Than Tun Zaw led by by Sayar Swan (aka) Htet Shine Zaw armed with two pistols reportedly robbed K44.9 million from the bank at gunpoint. It was also found out that Sayar Swan (aka) Htet Shine Zaw was back to Mandalay after hiding in Nyaung-U township.
- The security personnel then conducted follow-up actions to arrest the suspect

Sayar Swan (aka) Htet Shine Zaw and he was found at Lotteria burger shop located at 84<sup>th</sup>, 62<sup>nd</sup> x 63<sup>rd</sup> in Mahar Aungmyay township on 25 June. During the arrest, the suspect attempted to escape by shooting back the security personnel. Therefore, security personnel shot him back in defence and the suspect was arrested dead along with a Glock pistol, its two magazines and 19 rounds of 9-mm bullet.

- It was found out that Than Tun Zaw, Kaung Khant Naung and Sayar Swan (aka) Htet Shine Zaw had attended the explosive course for a month at the PDF terrorist group in Kani township, Monywa district of Sagaing region and the so-called Yadanarphone Revolution was organized with 25 members led by Sayar Swan (aka) Htet Shine Zaw.
- It was also found out that the so-called Yadanarphone Revolution was organized with certain intentions such as: to carry out acts of terrorism to disrupt the State's administration mechanism; to kill

## **Actions Continue against Unscrupulous Persons who Follow and Make Incitements and Propaganda of CRPH and NUG Terrorist Groups, their Subordinates and Colluded Groups**

The entire population has already been informed not to follow the groups, their subordinates and colluded groups. In spite of that, some unscrupulous persons made incitements and propaganda to disrupt the State peace and stability via social media. Therefore, necessary actions have been taken against them in accordance with the law. In this regard:

- From 22 to 28 June, three from Nay Pyi Taw Council Territory, six from Yangon region, eight from Bago region, nine from Mandalay region, eight from Magway region, one from Ayeyawady re-

gion, 14 from Taninthayi region, five from Sagaing region, two from Mon state, one from Kachin state, one from Chin state and three from Shan state, totaling 61 were arrested.

- From 27 January to 28 June, legal actions were taken against a total of 567 people under the law.

It is reported that necessary actions will be continued against such instigators and unscrupulous persons making propaganda and instigations.
