Mr. Prak Sokhonn, Special Envoy of the ASEAN chair on Myanmar, Deputy Prime Minister and Minister of Foreign Affairs and International Cooperation of Cambodia, at the Credentials Hall of the SAC Chairman's Office in Nay Pyi Taw on 30 June.

During the meeting, they cordially exchanged views on the following points:

- The implementation of the five-point ASEAN consensus and progress.
- Deaths of members of the Sangha, novices, innocent people, teachers, service personnel and security members due to terrorist attacks and killing of so-called PDF terrorists who were born of NUG and CRPH, and damage of public and State-owned buildings in bomb blasts

- and the outbreak of fires committed by those PDFs.
- Efforts being made for the elimination of terrorism, the reopening of schools, the progress of holding peace talks with ethnic armed organizations for the restoration of perpetual peace.

The Chairman of State Administration Council Prime Minister Senior General Min Aung Hlaing, accompanied by responsible officials, inspected the construction of Naypyitaw State Academy (NSA) in Zabuthiri Township in Nay Pyi Taw Council Area on 1 July.

First, the officials reported to the Senior General on construction tasks and plans teaching programs. After hearing the reports, the Senior General stressed the following points:

- As higher education facilities and faculty building are essential to promote the education of the new generations of government employees working in Nay Pyi Taw, the seat of the government office, the Naypyitaw State Academy project has been implemented after consultation with responsible officials.
- In selecting students, it is vital to mainly select offspring of government employees in Nay Pyi Taw and residents of eight townships in Nay Pyi Taw who meet designated qualifications and priority must be given to outstanding students in respective subjects.

- Measures must be taken to open courses for third- and fourth-year day students starting from the current academic year and first- and second-year students will be allowed to study at the university step by step.
- Transportation services will be arranged for students in the current academic year so that they can go to the academy from their respective houses. Measures will be taken to build halls of residence in the future to enable students to study at the academy while staying in university halls of residence.
- The NSA will offer arts, science, economics, law, sociology, sports and medicine courses. Efforts must be made to enhance Yangon University, Mandalay University and the NSA to be leading universities in the country with the aim of including them in the list of best universities in the world.

Then, the Senior General and party inspected classroom buildings, construction of the main hall and the display of teaching facilities and aids in the main building.

The Chairman of State Administration Council Prime Minister Senior General Min Aung Hlaing, accompanied by entourages, inspected the Dala Shipyard in Yangon region on 2 July. In his response to the reports by officials on Dala shipyard, the Senior General stressed the following points:

- Although water transport is the most cost
 -effective and fastest way to transport a
 large number of goods in the transport
 sector of the country, there is no proper
 development for it fails to conduct systematically.
- There should be fine waterways, jetties, ships, resting areas on the jetty for passengers, locations for freight transport and places to keep the products.
- It should make efforts to lure the trust of people in the water transport sector. If measures can be taken to improve water transport system, it will certainly be to the country' benefit.
- The local transport sector received proper achievements in the past but the Stateowned transport was affected seriously

- due to financial difficulties and smuggling.
- Due to the weaknesses in repairing the aged machinery and ships, it affects the State-owned transport sector and so it needs to conduct repair works on them based on their terms or years correctly.
- It also should adopt the coastal transport system, carrying goods by car first and then using vessels.
- It should use the delta region and rivers such as Ayeyawady, Chindwin and Thanlwin effectively in the inland water transport sector.
- It should build modern ships and shipbuilding can be studied at the partnershipyards.
- If the people prefer inland water transport with a sense of trust, the nationwide travel and flows of trade can be improved and there will be an economic system that can be launched across the nation.

Myanmar Strongly Rejects Unilateral Decisions and Conclusions Adopted during the 110th Session of the International Labour Conference

Ministry of Labour released a statement describing that Myanmar strongly protests and rejects the decisions and conclusions against Myanmar that were adopted respectively by the 345th Session of the ILO Governing Body and the Committee on Application of Standards during the 110th Session of the International Labour Conference

(110th ILC) which was held in Geneva, Switzerland from 27 May to 11 June 2022 without the participation of Myanmar. Myanmar further reiterates its objection against the establishment of the Commission of Inquiry in the absence of the country concerned goes against the ILO Constitution.

Statement

- 1. It is observed that the decisions and conclusions against Myanmar were adopted respectively by the 345th Session of the ILO Governing Body and the Committee on Application of Standards during the 110th Session of the International Labour Conference (110th ILC), which was held in Geneva, Switzerland from 27 May to 11 June 2022 without the participation of Myanmar.
- 2. These decisions and conclusions were derived from the Report of the ILO Director-General on Development in Myanmar and the 2022 Report of the Committee of Experts on the Application of Conventions and Recommendations. In this regard, Myanmar has already conveyed its observations to the respective bodies of the ILO. The reports contained excessive politically motivated elements rather than labour-related matters and they are not credible. The elements contained in the reports have heavily relied on distorted information and fabricated news, which are deliberately disseminated by the so-called labour activists. Accordingly, it is not surprising to see that the decisions and conclusions are largely politicized.
- 3. It is also observed that the ILO ignores the essence of the tripartite mechanism in implementing the Decent Work Country Program and in providing technical assistance without engaging the government. The ILO neglects the internationally-accepted principle of providing assistance at the request of the country concerned. The Government of Myanmar has been implementing activities to assist the workers and employers with tripartite nature.
- 4. The decisions also mentioned the Commission of Inquiry which was established in March 2022 and questioned Myanmar's compliance with the Freedom of Association and Protection of the Right to Organize Convention, 1948 (No 87) and the Forced Labour Convention, 1930 (No 29). In reality, there are 2,892 Basic Labour Organizations; 162 Township Labour Organizations; 26 Region and State Labour Organizations; nine Labour Federations; one Labour Confederation in Myanmar with 190,000 members of such labour organizations. It is not true and appropriate to generalize that Myanmar is not upholding its obligations under Convention No 87 because of taking legal actions against a handful number of so-called labour activists for inciting the general public to commit violence and unrest.

- 5. In Myanmar, the National Complaint Mechanism on Eliminating Forced Labour of Myanmar (NCM) was established in 2020. The report of the ILO Director-General mentioned that since February 2021, the ILO received 13 individual complaints that are subject to further assessment while no cases have yet been submitted to the NCM. It is incomprehensible to learn that the ILO Liaison Office takes one and half years to submit the cases to the NCM. Furthermore, the allegations regarding the use of forced labour were made without verifiable information such as names of individuals, location and date of incidents.
- 6. For these reasons, Myanmar strongly protests and rejects the decisions and conclusions adopted at the 345th Session of the ILO Governing Body and the Committee on Application of Standards. Myanmar further reiterates its objection against the establishment of the Commission of Inquiry in the absence of the country concerned goes against the ILO Constitution.



As the State Administration Council has been striving for the development of domestic and foreign investment for the good of the State and people, the State has sent invitations to the entrepreneurs from abroad through respective Myanmar embassies.

- At present, under the Special Economic Zone Law, 122 investments in total, from 20 countries and regions with the investment value of USD 2172.902, have been granted in Myanmar Special Economic Zone (Thilawa) as of April 2022.
- The investments in the fields of: production of fertilizer, cement, and steel; agriculture and livestock; production of value-added food items; electronic-powered vehicles; production of medicines and

- health-related equipment; and public sector will be prioritized.
- The major investments during the period from November 2014-2015 FY to April 2022 are found out to be the fields of trading goods, transports, services, housing development and hotels.
- According to the data on the investments, majority of the investments are from Japan, Singapore and Thailand. Moreover, there are also investments from United Kingdom, Republic of Korea, Hong Kong - special administrative regions of China, Taiwan (Republic of China), Austria, UAE, Malaysia, Australia, Netherlands, Panama, Denmark, People Republic of China, Brunei, Vietnam, Switzerland and France.

The Management Committee of Myanmar Special Economic Zone (Thilawa) have granted permits of investments Under the Special Economic Zone Law and domestic and foreign entrepreneurs can reportedly invest by submitting applications to the committee.

Due to the ease of travelling restrictions, foreign travelers from 47 countries including China, India, Thai, Korea, Japan, Malaysia, Taiwan, Viet Nam, Singapore and the U.S.A are entering Myanmar. Accordingly, the Ministry of Hotels and Tourism are undertaking the tasks in real time for interna-

tional tourists to travel comfortably in the country and fulfill their requirements.

Tourists who are visiting Myanmar need to fill necessary information such as package tour or Foreign Independent Traveler (FIT) and so on in the e-Visa form. They are also required to fill the names of hotels and guest houses where they are going to stay and the places where they are going in the arrival cards which are distributed to travelers on board.

The Ministry of Hotels and Tourism are now carrying out the Guest List Management System (GLMS) to know the number



of the international tourists staying at hotels and guest houses in real time. The Ministry will also take measures to attract more tourists and attend to their needs since the open travelling season is coming soon.

PDF Terrorists Make Disruptive Acts against Education Sector Development to Create Uneducated Classes in the Society

The terrorists of political extremist made the following disruptive acts against education sector with the use of various heinous means:

- On 28 June, two male terrorists riding a motorbike threw a homemade soundbomb at the Ye Pyar Basic Education High School in Ye Pyar village of Pauk township in Magway region and ran away. The bomb reportedly dropped and exploded in the area to the northwest of the school.
- On 29 June, PDF terrorists dropped a homemade bomb on the Basic Education Middle School in Kawt village of Shwebo township in Sagaing region with the use of a drone, taking position at Boodaw Taw village. It is reported that the bomb fell and exploded on the roof of the school, leaving it damaged.
- On 1 July, terrorists planted and exploded an IED inside an abandoned school building made of bamboo and zinc-roof

- located 50 feet away to the west of the main school building of the Basic Education Middle School-BEMS of the Kyikone village of Kyun Hla township.
- On 1 July, the dead body of a junior assistant teacher U Nay Soe of 38 from the BEMS of Thayaung village of Phaung Byin township was found near the graveyard of Innwine village with three cut wounds on the throat. He reportedly left the village in the morning of 30 June to attend the meeting at the Phaung Byin education office, never came back since then and was killed by terrorists.

The terrorists' intentional attacks against non-military targets of schools and non-combatant targets of teachers and students amount to war crimes, according to the provisions of Geneva Conventions and the International Law. As NUG's affiliate PDF terrorists are extremely full of envy on the opening of schools which perform to uplift the education quality of the youths in future,

they carry out arson and bomb attacks on, and fire small arms at education offices and schools. In addition to these, terrorists are continuously making brutal killings of innocent education staff. Security forces are reportedly carrying out investigations to identify and arrest those who were involved in the crimes and take punitive legal actions against them.

A Male Attempting to Make a Bomb Attack on Myanma Economic Bank Arrested

An improvised bomb blew up on 29 June while a male was making an attempt to launch a bomb attack on the Myanma Economic Bank in Hlaingthaya township (eastern) of Yangon region leading the arrest of the attacker.

During the incident, the security force members arrived the scene after hearing the explosion and found out that the improvised bomb blew up while Htet Aung Ko (aka) Ko Aung of 16, who lives in Hlaingthaya township (eastern), was making an attempt to make a bomb attack on the bank. The culprit was arrested at the scene with shrapnel wounds. No damages were reported during the bomb blast.

With the aim to cause public panic, terrorists upholding extreme dogma gave

youths incentives to make such bomb attacks. As the youths did short-course trainings of setting up and planting IEDs in EAOs area and via online applications and websites, they do not have sufficient skills on IEDs, and frequent explosions have taken place during their attempts to set up IEDs claiming their lives. It is found out that 45 terrorists were dead and 37 were injured until 1 July in 41 bomb explosions.

Security force members are also pursuing necessary measures to take punitive legal action against the perpetrator and others involved in an attempt to make the bomb attack.

• On 16 June, Thant Zin Aung (aka) TK Boss and E One encountered with security personnel when the two attempted to plant a mine near a Point-Htake bus-stop on Ayeyarwaddy road in Dagon Myothit (south) township. When security personnel arrested them, they popped in a vehi-

cle nearby and attempted to escape by driving through the security personnel. As security force members had to stop them by firing, Thant Zin Aung (aka) TK Boss was arrested with an IED while another offender E One was arrested dead.

- Lwin Oo Maung and Chit Ko Ko (aka)
 Chit Min Hlaing, members of so-called Yangon Union Young Organization-YUYO, were arrested in Thingangyun township.
- It was found out that Nyein Su Yi Phyo (aka) Wai Yan, Moe Powint Phyu (aka) La Yaung, Wa Wa Oo (aka) Pan Pan, Nyan Lin Htet (aka) Ko Nyan, Aung Min Khant (aka) Tha-khwar-thee had attended training course of handling explosives for 10 days in TNLA Brigade (6) in June 2021.
- In order to carry out terrorist bombing attacks in Yangon city, the so-called TKF terrorist group was found led by Nyein Su Yi Phyo (aka) Wai Yan with the members of Kaung Thiha Naing (aka) Zinyaw, Moe Powint Phyu (aka) La

- Yaung, Wa Wa Oo (aka) Pan Pan, Nyan Lin Htet (aka) Ko Nyan, Aung Min Khant (aka) Tha-khwar-thee and Htet Nanda Theint (aka) Nanda in July 2021.
- It was also found out that the terrorist group called YUYO was founded led by offender Kyaung Nat (to be arrested) with 11 members including Lwin Oo Maung and Chit Ko Ko (aka) Chit Min Hlaing in December 2021.

The TKF and YUYO terrorist groups, with the intents to paralyze the State administration mechanism and also to make people frightened, committed a targeted killing of an innocent civilian and terrorist bombing attacks for six times as follows –

- The offender Chit Ko Ko (aka) Chit Min Hlaing assassinated U Hla Moe, the administrator of Sin Min ward of Alone township on 17 May 2022.
- The offenders Lwin Oo Maung and Chit Ko Ko (aka) Chit Min Hlaing exploded two IEDs in front of the township court in Kyimyindine township and Yamonna market of the town on 1 February 2022.

- Moreover, the two offenders exploded two IEDs near Hanthawady petroleum shop located in front of Hanthawady train station, and in the township police station in Kyinmyindine township on 31 March 2022.
- The offenders Lwin Oo Maung and Chit Ko Ko (aka) Chit Min Hlaing also exploded an IED in front of a civilian house located on U Kywal Hoe street of Kyimyindine township on 13 April 2022.
- On 16 June, Thant Zin Aung (aka) TK Boss attacked a police security outpost

located on Ayeyarwady road of Dagon Myothit (south) township by throwing a homemade mine to it.

It is reported that necessary measures will be taken to take punitive legal actions against the arrested offenders.
